JOURNAL OF THE SENATE.

Monday, October 21, 2013.

Met according to adjournment at eleven o'clock A.M. (Mr. Petrucci in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Petrucci), members, guests and staff in the recitation of the pledge of allegiance to the flag.

Petition.

Mr. Petrucci presented a petition (subject to Joint Rule 12) of Anthony W. Petrucci for legislation relative to Medicaid,-- **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**

PAPERS FROM THE HOUSE.

Bills

Relative to combining the offices of town treasurer and town collector in the town of Dudley (House, No. 1833,-- on petition)

[Local approval received]; and

Authorizing the city of Revere to issue bonds or notes for the payment of a litigation settlement (House, No. 3687,-- on petition)

[Local approval received];

Were severally read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

On motion of Mr. Tarr, the above communication was ordered printed in the Journal of the Senate.

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and consider, as follows:

The House Bill authorizing the town of Norfolk to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (House, No. 307),-- **was read a third time and passed to be engrossed, in concurrence.**

The House Bill relative to the form of government in the town of Paxton (House, No. 3533),-- **was read a third time and passed to be engrossed, in concurrence.**

The House Bill authorizing the town of Concord to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (House, No. 3615),-- **was read a third time.**

Pending the question on passing the bill to be engrossed, Mr. Barrett presented an amendment in section 1, by adding the following paragraph:-

"Upon issuance of the license authorized in this act, Nine Acres Wines, Inc. shall surrender to the licensing authority the license it currently holds for the sale of wines and malt beverages not to be drunk on the premises."

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment.
Sent to the House for concurrence.

The House Bill authorizing the town of Natick to grant a license for the sale of all alcoholic beverages to be drunk on the premises (House, No. 3616),-- **was read a third time and passed to be engrossed, in concurrence.**

Report of a Committee.

By Mr. Brewer, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Jessica Culver, an employee of the Department of Mental Health (Senate, No. 1871),-- **ought to pass, with an amendment substituting a new draft with the same title (Senate, No. 1888).**

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 1888) was then ordered to a third reading, read a third time and passed to be engrossed.
Sent to the House for concurrence.

Engrossed Bills.

The following engrossed bills (all of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Petruccelli) and laid before the Governor for his approbation, to wit:

Establishing a sick leave bank for April D. Robinson, an employee of the Department of Developmental Services (see House, No. 3628);

Establishing a sick leave bank for Katherine Swearingen, an employee of the Department of Developmental Services (see House,

No. 3660); and

Relative to a lease agreement for land in the town of Tewksbury between the Division of Capital Asset Management and Maintenance and the Tewksbury Hospital Equestrian Farm (see House, No. 3663, amended)

Resolve Passed.

An engrossed Resolve providing for an investigation and study by a special commission relative to the feasibility of hosting the summer Olympics in the Commonwealth (see Senate, No. 1840, amended) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed and signed by the Acting President (Mr. Petrucci) and laid before the Governor for his approbation.

Order Adopted.

On motion of Mr. Tarr ,--

Ordered, That when the Senate adjourns today, it adjourn to meet again tomorrow at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.
