JOURNAL OF THE SENATE.

Friday, October 31, 2014.

Met at three minutes past ten o'clock A.M. (Mr. McGee in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The President, members, guests and staff then recited the pledge of allegiance to the flag. PAPERS FROM THE HOUSE.

A Bill establishing a sick leave bank for Stephanie Deronette, an employee of the Executive Office of Health and Human Services (House, No. 4506,-- on petition), -- was read and, under Senate Rule 27, referred to the committee on Ways and Means.

A Bill relative to special police officers in the town of Norwood (House, No. 4196,-- on petition) [Local approval received],-- was read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

A communication from the Department of Energy Resources of the Executive Office of Energy and Environmental Affairs (under the provisions of Section 12 of Chapter 25A of the General Laws) submitting amendments to 225 CMR 19- Energy Management Services (EMS) Contract, Request for Qualifications Process ("EMS Regulations") (House, No. 4515),-- was referred, in concurrence, to the committee on Telecommunications, Utilities and Energy.

There being no objection, at four minutes past ten o'clock A.M., the Chair (Mr. McGee) declared a recess subject to the call of the Chair; and, at twenty minutes before twelve o'clock noon, the Senate reassembled, Mr. McGee in the Chair. PAPERS FROM THE HOUSE.

The House Bill making appropriations for the fiscal year 2014 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 4508),-- came from the House with the endorsement that the House had concurred in the further Senate amendment, with a still further amendment striking out all after the enacting clause and inserting in place thereof the text of House document numbered 4516.

There being no objection, the rules were suspended on motion of Mr. Brewer, and the still further House amendment was considered forthwith and adopted, in concurrence.

Emergency Preambles Adopted.

An engrossed Bill establishing a sick leave bank for Therese Cormier, an employee of the Trial Court (see Senate, No. 2389), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment.

An engrossed Bill establishing a sick leave bank for Tina Jarbeau, an employee of the Executive Office of Health and Human Services (see House, No. 4428), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President (Mr. McGee) and sent to the House for enactment. Engrossed Bills.

The following engrossed bills (the first of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. McGee) and laid before the Governor for his approbation, to wit:

Authorizing Cary Gould to take the civil service examination for appointment as a police officer in the city of Gloucester notwithstanding the maximum age requirement (see Senate, No. 2282); and

Further regulating limited liability companies (see House, No. 4380).

Emergency Preamble Adopted.
