JOURNAL OF THE SENATE.

Monday, December 22, 2014.

Met at three minutes past eleven o'clock A.M. (Mr. Timilty in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Timilty), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Timilty) handed the gavel to Mr. Richard T. Moore for the purpose of an introduction. Mr. Richard T. Moore then introduced, in the rear of the Chamber, the Hopedale High School "Blue Raiders" Boys Cross Country Team. The team was recognized for winning the 2014 Division 2 State Championship. They were accompanied by Head Coach Joe Drugan, who has guided the team for 21 years as head coach and has attained eight Central Massachusetts Championship titles and three State Championship titles. The Senate applauded their accomplishments and they withdrew from the Chamber. They were also guests of Representative Fernandes.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment.

Mr. Rosenberg, for the committee on Ethics and Rules, reported that the following matter be placed in the Orders of the Day for the next session;

The House Bill increasing the amount of money that may be borrowed by the Thorndike Fire and Water District in the town of Palmer (House, No. 4503).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

By Ms. Flanagan, for the committee on Ways and Means, that the House Bill relative to the leasing of certain land owned by the Worcester City Campus Corporation (House, No. 4379),-- ought to pass (Senator Ross dissenting).

There being no objection, the rules were suspended, on motion of Mr. Richard T. Moore, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

By Mr. Brewer, for the committee on Ways and Means, that the House Bill establishing 6-year career plans for all Massachusetts public school students (House, No. 4527, amended),-- ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2420.

There being no objection, the rules were suspended, on motion of Mr. Richard T. Moore, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment.

By Mr. Brewer, for the committee on Ways and Means, that the House Bill establishing a sick leave bank for Mr. Matt McConville, an employee of the Department of Revenue (House, No. 4541, amended),-- ought to pass.

There being no objection, the rules were suspended, on motion of Mr. Richard T. Moore, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: 'An Act establishing a sick leave bank for Matthew McConville, an employee of the Department of Revenue".

By Ms. Forry, for the committee on Municipalities and Regional Government, on petition, a Bill to authorize the board of selectmen to exempt certain eco-toilet installations from sewer connections and associated betterments in the town of Falmouth (Senate, No. 2412) [Local approval received].

The bill was read. There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.

The Senate petition of Mr. Joseph Toolan for legislation to establish the Culture & Company Investment Corporation Law "CCIC's Law" (having been returned by the Secretary of the Commonwealth under Section 5 of Chapter 3 of the General Laws, with memorandum relative thereto),-- was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.

Subsequently, Mr. Rosenberg, for the said committees on Rules of the two branches, acting concurrently, reported, recommending that Joint Rule 12 be suspended on said petition.

Senate Rule 36 was suspended, on motion of Mr. Richard T. Moore, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Tourism, Arts and Cultural Development.

Sent to the House for concurrence.
