Thursday, December 8, 2016.

Met at eight minutes past eleven o'clock A.M. (Mr. Rush in the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

## Adjourn In Memory of Eleanor (Applebaum) Myerson

The Senator from Middlesex and Norfolk, Ms. Creem moved that when the Senate adjourns today, it adjourn in memory of Brookline and Cataumet resident Eleanor (Applebaum) Myerson, who died November 20, 2016 at the age of 94.

A very progressive and well-liked activist, Ms. Myerson was a dynamic member of town and Democratic politics. She served three terms on the Brookline Board of Selectmen and four terms (1983-1991) representing the 11th Suffolk district (Brookline/Boston) in the State Legislature.

After graduating from Brookline High School, Ms. Myerson went to Smith College, from which she received a bachelor's degree in 1943. While still a student, she married developer Morton Myerson in 1942. They were married for more than 71 years when he died in 2014.

Joining the Democratic Party while working on Adlai Stevenson's presidential campaign in 1952, Ms. Myerson became a Brookline Town Meeting member prior to being one of the first women elected to Brookline's Board of Selectmen, which she eventually chaired.

Mrs. Myerson, who was 60 when she was initially elected to the House, was active in housing and tenant issues on the town and state levels and advocated in the Legislature on behalf of elder services and adult literacy.

In July 1983, she was named chairwoman of the Massachusetts Caucus of Women Legislators at a time when only 26 women served in the Legislature, or 13.5 percent - 20 in the House, six in the Senate. Women in the Legislature had formed the group in 1975 to work together on issues of common concern.

Choosing to not run after 4 terms, Ms. Myerson and her husband retired in 1989 to Cataumet, where they had spent summers since 1972. Mrs. Myerson was a member of the Cataumet Club, the Cataumet Civic Association and the Pocasset Golf Club.

Former governor Michael Dukakis referred to Ms. Myerson as "quite a force. She was part of a hardy band of younger Democrats who decided to assume responsibility of the Democratic Party in Brookline, and they proceeded to do great things."

Eleanor Applebaum Myerson will be deeply missed by her daughter, Ann Myerson of Brookline, her son and daughter-in-law, Joseph Myerson and Lynne

Johnson of Bolton, two sisters-in-law, Harriet Myerson of Newton and Betty Appleton of Natick, numerous nephews and nieces, and members of the Brookline and Cataumet communities.

Accordingly, as a mark of respect in memory of Eleanor (Applebaum) Myerson, at twenty-four minutes past eleven o'clock A.M., on motion of Mr. O'Connor, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
