Monday, December 12, 2016.

Met at four minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Chapter 29 of the General Laws) relative to reductions in certain executive branch accounts to address a projected budget shortfall in fiscal year 2017,-- **was read for its information and returned to the House to be placed on file.**

A petition (accompanied by bill, House, No. 4753) of Bradley H. Jones, Jr., Jason M. Lewis and James J. Dwyer (by vote of the town) that the town of Reading be authorized to issue additional licenses for the sale of all alcoholic beverages and for the sale of wines and malt beverages,-- **was referred, in concurrence, to the committee on Consumer Protection and Professional Licensure.**

**There being no objection, the rules were suspended, on motion of Mr. Ross, and the bill was read a second time and ordered to a third reading.**

The Senate Bill designating a certain intersection in the town of Plainville as the Special Police Officer Michael O. Maher Memorial Intersection (Senate, No. 2165),-- came from the House, passed to be engrossed, in concurrence, *with an amendment* in lines 3 and 4 by striking out the word “Michael” and inserting in place thereof, in each instance, the word “Mike”; and by striking out the title and inserting in place thereof the following title: “An Act designating a certain intersection in the town of Plainville as the Special Police Officer Mike O. Maher Memorial Intersection”.

*Emergency Preamble Adopted.*

An engrossed Bill establishing a sick leave bank for Jennifer Gay, an employee of the Department of Developmental Services(see House, No. 4366, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.
