JOURNAL OF THE SENATE.

At a General Court of the Commonwealth of Massachusetts, held on the first Wednesday, being the sixth day of January, in the year two thousand and sixteen, and the two hundred and fortieth of the independence of the United States of America, a quorum of the members of the Senate, elected for a term of two years at an election held on Tuesday next after the first Monday of November in the year 2014, assembled at six minutes past eleven o'clock A.M., in the Senate Chamber, and were called to order by the Honorable Patricia D. Jehlen.

The Chair (Ms. Jehlen), members, guests and staff then recited the pledge of allegiance to the flag

Severally sent to the House for concurrence.

PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 3924) of William M. Straus (by vote of the town) that the town of Mattapoisett be authorized to require a two thirds majority vote of the town meeting to modify the bylaws of said town,-- **was referred, in concurrence, to the committee on Municipalities and Regional Government.**

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The House Bill relative to the composition of the Nantucket Historic District Commission (House, No. 3618, amended),-- **was read a third time and passed to be engrossed, in concurrence.**

PAPER FROM THE HOUSE

Emergency Preamble Adopted.

An engrossed Bill regulating sewer betterment assessments in the Commonwealth (see House, No. 3654), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before

the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President (Ms. Jehlen) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Clair) and sent to the House for enactment.

Recess.

There being no objection, at nine minutes past eleven o'clock A.M., the Chair, Ms. Jehlen declared a recess subject to the call of the Chair; and, at twelve minutes past one o'clock P.M., the Senate reassembled, Ms. Chandler in the Chair.

Orders Adopted.

On motion of Mr. Donnelly,--

Ordered, That a committee be appointed to inform the House of Representatives that the Senate is now assembled and ready to proceed to business.

Senators Petrucci, Lovely, and deMacedo were appointed the committee.

Subsequently, Mr. Petrucci for the said committee, reported that it had attended to its duty. The committee was discharged.

On motion of Mr. Montigny,--

Ordered, That a committee of members of the Senate and the House of Representatives be appointed to wait upon His Excellency the Governor, Charles D. Baker, Lieutenant-Governor Karyn E. Polito and the Honorable Council and inform them that the two branches of the General Court are now assembled and ready to proceed to business.

Subsequently, Senators Donnelly, Lewis, and Humason were appointed the committee.

Sent to the House for concurrence.

Subsequently, the order was returned with the endorsement that the House had concurred and that Representatives Petrolati of Ludlow, Fennell of Lynn, Campanale of Leicester, Chan of Quincy, Cutler of Duxbury, Day of Stoneham, D'Emilia of Bridgewater, Kelcourse of Amesbury, McGonagle of Everett, O'Connell of Taunton, Calter of Kingston, Holmes of Boston, Moran of Lawrence, Scaccia of Boston, Timilty of Milton, Smola of Warren and Tosado of Springfield were appointed the committee on the part of the House.

Mr. Donnelly, for the said committee, afterwards reported that it had attended to its duty and the committee was discharged.

Committee of the House.

The Chair (Ms. Chandler) welcomed a committee of the House of Representatives that arrived to declare that the House of Representatives was now assembled and ready to proceed to business

Orders Adopted.

On motion of Mr. Petrucci,--

Ordered, That the Clerk begin the daily printing of the Journal of the Senate, as authorized by Senate Rule 6, and that the daily reading thereof be dispensed with; that, under authority of Section 22A of Chapter 3 of the General Laws, copies of the Journals of the entire session be printed and bound with the customary appendices and an index; and that a certified copy thereof be deposited with the Secretary of the Commonwealth as the official bound Journal of the Senate.

On motion of Mr. Lewis,--

Ordered, That when the Senate adjourns today, it adjourn to meet again tomorrow at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.

On motion of Mr. Humason, at sixteen minutes before two o'clock P.M., the Senate adjourned to meet again tomorrow at eleven o'clock A.M.
