JOURNAL OF THE SENATE.

Monday, March 9, 2015.

Met at two minutes past eleven o'clock A.M. (Mr. Keenan in the Chair).

The Chair (Mr. Keenan), members, guests and staff then recited the pledge of allegiance to the flag.

Communications.

The following communications were received and placed on file, to wit:

Communication from the Office of the Comptroller (under the provisions of 1599-2040 of Section 2B of Chapter 165 of the Acts of 2014) submitting its report relative to paid prior year deficiencies (received March 9, 2015);

Communication from the Office of the Comptroller (under the provisions of Section 6B of Chapter 29 of the General Laws) submitting its report relative to the status of federal funds applied for, received and expended (received March 9, 2015); and

Communication from the Office of the Comptroller (pursuant to Section 2E of Chapter 165 of the Acts of 2014) submitting the Fiscal Year 2015 transfer schedule for account 1595-1068 Medical Assistance Trust Fund (received February 13, 2015).

Petitions.

The following petition, having been timely filed by 5:00 P.M., on Friday, January 16, 2015, was considered as follows:--

A communication from the Insurance Fraud Bureau (see Section 1 (k) of Chapter 338 of the Acts of 1990, as most recently amended by Section 5 of Chapter 279 of the Acts of 2002) submitting a semi-annual report relative to referrals involving automobile insurance fraud, workers' compensation fraud and other insurance fraud,-- **was read for its information and returned to the House to be placed on file.**
