JOURNAL OF THE SENATE.

Monday, June 20, 2016.

Met at five minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Senators Brownsberger, Chang-Diaz and Tarr were appointed to the committee on the part of the Senate.

The bill was returned to the House endorsed accordingly.
