JOURNAL OF THE SENATE.

Monday, June 29, 2015.

Met at seven minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Communication.

The following communications were severally received and placed on file to wit:

Communication from the Honorable Stanley C. Rosenberg, President of the Senate announcing the resignation of Senator Thomas M. McGee as Co-Chair and the appointment of the Honorable Joan B. Lovely as Co-Chair of the Special Commission established (pursuant to Chapter 313 of the Acts of 2010) to make an investigation and study of Postpartum Depression (Senator McGee will retain his appointment to the Commission); and

Communications from the Department of Public Health; relative to plans of corrections submitted pursuant to inspection of Berkshire County Jail and House of Corrections, Franklin County Jail and House of Correction, MCI Cedar Junction and Suffolk County House of Correction (received June 25, 2015).

Report.

Ms. Lovely, for the committee on State Administration and Regulatory Oversight, reported, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 1704) of Marc R. Tarr for legislation to promote solar hot water installations,-- **and recommending that the same be referred to the committee on Environment, Natural Resources and Agriculture;**
Under Senate Rule 36, the report was considered forthwith and accepted.

Adjourn In Memory of Walter T. Kostanski, Jr.,

The Senator from Hampshire, Franklin and Worcester, Mr. Rosenberg, moved that when the Senate adjourns today, it adjourn in memory of Walter T. Kostanski, Jr., of Turners Falls.

Walter T. Kostanski, Jr. passed away on June 15, 2015 surrounded by his loving family.

Walter was born in Erving and attended Turners Falls High School, where he was an ace pitcher for the undefeated state championship baseball team.

After graduating Walter went on to serve in the United States Naval Armed Guard as a Gunner's Mate Third Class from 1943-1946.

For his service he was awarded the WWII Victory Medal, the American Area Campaign Ribbon, the European-African Area Campaign Ribbon, the Asiatic – Pacific Area Ribbon and the Philippine Liberation Medal.

Walter was a tireless public servant, serving for 14 years in the Massachusetts House of Representatives and 24 years as Register of Deeds for Franklin County.

As a member of the House of Representatives, he was instrumental in securing funding for Silvio O. Conte Fish Research Laboratory in Turners Falls, establishing the first boat ramp on the Connecticut River in Gill, establishing a Massachusetts Rehabilitation Commission Office in Greenfield, passing legislation to establish Greenfield Community College and Franklin County Technical School.

Even after retirement Walter continued to play an active role in his region and in 2009 he was integral in bringing a new Public Safety Complex to Montague.

Walter is survived by his wife of 68 years, Virginia, his four children, Barry and his wife Patty of Turners Falls, Richard and his wife Amy-Jo of South Deerfield, Marilyn and her partner Monica Bartolucci of Millers Falls, and Mary and her husband Dan Brost of Tucson, Arizona, five grandchildren and three great grand-children.
