JOURNAL OF THE SENATE.

Thursday, August 6, 2015.

Met at five minutes past eleven o'clock A.M. (Mrs. L'Italien in the Chair).

The Chair (Mrs. L'Italien), members, guests and staff then recited the pledge of allegiance to the flag.

Communications.

The following communications were severally received and placed on file:

Communication from the Middlesex Sheriff's Office; relative to a plan of correction submitted pursuant to inspection of the Middlesex County House of Correction June 1, 2 and 3, 2015 (received August 4, 2015); and
