JOURNAL OF THE SENATE.

Thursday, August 27, 2015.

Met at six minutes past eleven o'clock A.M. (Ms. Lovely in the Chair).

The Chair (Ms. Lovely), members, guests and staff then recited the pledge of allegiance to the flag.

Communications.

The following communications were severally received and placed on file, to wit:

Communication from the Honorable Bruce E. Tarr, Senate Minority Leader, announcing the appointment (pursuant to Chapter 431 of the Acts of 2014) of Mr. Seth Yorra of Rockport as his designee to the Task Force on Child Sexual Abuse Prevention; and Communication from the Office of the Comptroller (pursuant to Section 2E of Chapter 165 of the Acts of 2014) submitting an updated Fiscal Year 2015 transfer schedule for the following account: 1595-1068 Medical Assistance Trust Fund (received August 21, 2015).

A Bill relative to the taking of property by the Medway Redevelopment Authority (House, No. 3361,-- on petition) [Local approval received],- **was read and, under Senate Rule 26, placed in the Orders of the Day for the next session.**

Matter Taken Out of the Orders of the Day

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The House Bill authorizing the appointment of retired police officers as special police officers in the city of Boston (House, No. 2339) (its title having been changed by the committee on Bills in the Third Reading),- **was read a third time and passed to be engrossed, in concurrence.**

Bill Returned with Recommendation of Amendment.

A message from His Excellency the Governor, returning with recommendation of amendment the engrossed Bill establishing a sick leave bank for Jeremy Bray, an employee of the Department of Correction (see House, No. 3657) [for message, see House, No. 3737],— came from the House with an amendment in the form approved by the committee on Bills in the Third Reading as follows:-

By inserting after the second sentence the following sentence: “Upon exhaustion of all other available leave time including personal days, vacation days, sick time and any time available pursuant to the extended leave illness bank established by section 4P of chapter 7 of the General Laws, Jeremy Bray shall be permitted to use any time credited to the sick leave bank established by this act.”.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was before the Senate subject to amendment and re-enactment.

The rules were suspended, on motion of Mr. Tarr, and the Governor’s amendment was considered forthwith.

On motion of the same Senator, the Governor’s amendment was adopted, in concurrence (as corrected BTR).

Sent to the House for re-enactment.

Adjournment in Memory of Attleboro Mayor Judith Robbins

The Senator from Norfolk, Bristol and Middlesex, Mr. Ross, and the Senator from Bristol and Norfolk, Mr. Timilty, moved that when the Senate adjourns today, it adjourn in memory of former Attleboro Mayor Judith Robbins.

Judith Robbins served as Mayor of the City of Attleboro from 1991 to 2003, the second longest tenure of any mayor in city history, and was the city's second female mayor.

Judith was the first woman elected to the Attleboro city council and was the first female president of the city council.

She also served on Attleboro's Planning Board, the MBTA Board of Directors, and the committee responsible for rewriting Attleboro's city charter.

Following her tenure as mayor, Judith was appointed to the Attleboro Redevelopment Authority, and served as chairwoman.

Judith is survived by her husband Marcus, their two children, Andrew Robbins and Janet Robinson, two sisters, Susan Harris-Sharple of Plymouth and Hilary Penglase of North Egremont, and five grandchildren..
