By Ms. Spilka, for the committee on Ways and Means, that the Senate Bill relative to risk management and own risk and solvency assessment (Senate, No. 2276),-- ought to pass, with an amendment substituting a new draft with the same title (Senate, No. 2517).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2517) was then ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

By Ms. Spilka, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Kristine Schneider, an employee of the Department of Transitional Assistance (Senate, No. 2510),-- ought to pass, with an amendment inserting before the enacting clause the following emergency preamble:--

Kristine Schneider,--sick leave.

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of transitional assistance, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

There being no objection, the rules were suspended, on motion of Mr. Keenan, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2510, amended) was then ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

By Ms. Spilka, for the committee on Ways and Means, that the House Bill relative to snow removal penalties in the city of Boston (House, No. 3326, amended),-- ought to pass.

The Senate Bill relative to the provision of group health insurance benefits in the town of Athol (Senate, No. 1967),-- was read a third time and passed to be engrossed.

Sent to the House for concurrence.

The House Bill further regulating the interest rate on sewer assessments in the town of Stoughton (House, No. 3561) (its title having been changed by the committee on Bills in the Third Reading),-- was read a third time and passed to be engrossed, in concurrence.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment.

There being no objection, the rules were suspended, on motion of Mr. Keenan, and the House amendment was considered forthwith and adopted, in concurrence (as corrected BTR).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A Bill authorizing the city of Salem to grant an additional license for the sale of alcoholic beverages to be drunk on the premises (House, No. 4718,-- on House, No. 4696) [Local approval received on House, No. 4696],-- was read.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A Bill ratifying certain by-laws in the town of Easton (House, No. 4738,-- on petition) [Local approval received],-- was read.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A Bill providing for post-employment benefits for school bus drivers in the city of Pittsfield (House, No. 4763,-- on petition) [Local approval received],-- was read.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

An engrossed Bill facilitating urban redevelopment in the city of Quincy (see House, No. 4739) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Boncore) and laid before the Governor for his approbation.

# Emergency Preamble.

An engrossed Bill establishing a sick leave bank for Cecile Ferrie, an employee of the Department of Correction (see House, No. 4249, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Boncore) and sent to the House to be enacted.
