### JOURNAL OF THE SENATE.

Thursday, June 2, 2016.

Met at six minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Boncore), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Distinguished Guests.*

There being no objection, the Chair (Mr. Boncore) handed the gavel to Mr. McGee for the purpose of an introduction. Mr. McGee then introduced, in the rear of the Chamber, the 2015-2016 St. Mary's Lynn High School Basketball Team. The team was recognized for winning the Division 4 State Championship title by defeating Maynard by a final score of 61-52. This is the school's fourth boys' basketball state championship. The Senate applauded their accomplishments and they withdrew from the Chamber. The team was led by Coach David Brown. They were also guests of Senator Lovely and Representatives Walsh and Crighton.

## PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 4366) of Paul R. Heroux and Richard J. Ross for legislation to establish a sick leave bank for Jennifer Gray, an employee of the Department of Developmental Services,-- **was referred in concurrence, under suspension of Joint Rule 12, to the committee on Public Service.**

### *Engrossed Bill.*

An engrossed Bill authorizing the city of Easthampton to grant 8 additional licenses for the sale of all alcoholic beverages to be drunk on the premises (see Senate, No. 2284) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Boncore) and laid before the Governor for his approbation.

### *Recess.*

There being no objection, at twenty-nine minutes past eleven o'clock A.M., the Chair (Mr. Boncore) declared a recess subject to the call of the Chair; and, at seven minutes past twelve o'clock noon, the Senate reassembled, Mr. Boncore in the Chair.

## PAPER FROM THE HOUSE

The House Bill making appropriations for the fiscal year 2017 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 4201, amended),— came from the House with the endorsement that the House had NON-concurred in the further Senate amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate, No. 2305 and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representatives Dempsey of Haverhill, Kulik of Worthington and Smola of Warren have been appointed the committee on the part of the House.

**On motion of Mr. Tarr, the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Spilka, DiDomenico and deMacedo were appointed on the part of the Senate. The bill was returned to the House endorsed accordingly.**

### *Order Adopted.*
