### JOURNAL OF THE SENATE.

Thursday, June 4, 2015.

Met at three minutes past eleven o'clock A.M. (Ms. Jehlen in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Jehlen), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Distinguished Guests.*

There being no objection, the Chair (Ms. Jehlen) handed the gavel to Mr. Keenan for the purpose of an introduction. Mr. Keenan then introduced, in the rear of the Chamber, the fifth grade class from the Holy Family School in Rockland. The students were on a field trip to the State House learning about the different aspects of state government. The Senate welcomed them with applause and they withdrew from the Chamber.

There being no objection, the Chair (Ms. Jehlen) handed the gavel to Ms. Chandler for the purpose of an introduction. Ms. Chandler then introduced, in the rear of the Chamber, students from Mountview Middle School in Holden. The students were recognized for shoveling out seniors in their neighborhood during the snowstorms this past winter. The Senate applauded their hard work and they withdrew from the Chamber.

##### *Emergency Preambles Adopted.*

An engrossed Bill establishing a sick leave bank for Ellen Carlson, an employee of the Department of Developmental Services (see Senate, No. 39), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 4 to 0. The bill was signed by the Acting President (Ms. Jehlen) and sent to the House for enactment.**

An engrossed Bill establishing a sick leave bank for Rachel Zwetchkenbaum, an employee of the Department of Unemployment Assistance (see House, No. 3190, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 4 to 0.**

**The bill was signed by the Acting President (Ms. Jehlen) and sent to the House for enactment.**

##### *Reports of Committees.*

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Michael F. Rush and Edward F. Coppinger for legislation to establish a sick leave bank for John J. Monahan, an employee of the Trial Court.

**The rules were suspended, on motion of Mr. Timilty, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Judiciary.**

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Anne M. Gobi for legislation relative to a bridge in Barre.

**The rules were suspended, on motion of Mr. Timilty, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Transportation.**

**Severally sent to the House for concurrence.**

By Ms. Spilka, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Denise Dellagrotte, an employee of the Trial Court (Senate, No. 1923),-- **ought to pass, with an amendment substituting a new draft with the same title (Senate, No. 1933).**

**There being no objection, the rules were suspended, on motion of Mr. Keenan, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.**

**The bill (Senate, No. 1933) was then ordered to a third reading, read a third time and passed to be engrossed.**

**Sent to the House for concurrence.**

At the request of the Chair (Ms. Jehlen), the members, guests and staff stood in a moment of silence and reflection to the memory of Myron Klayman of Hull.

*Adjourn In Memory of Myron Klayman*

The Senator from Plymouth and Norfolk, Mr. Hedlund, moved that when the Senate adjourns today, it adjourn in memory of Myron Klayman of Hull.

Myron Klayman was a well known and loved member of the Hull community.

A longtime resident of Hull, Myron was actively involved in the town and played many roles.

He was a chairman and member of the Hull Board of Selectman from 1975 to 1983, where he was instrumental in helping to rebuild the battered town after the historic blizzard of 1978.

For more than 20 years, he managed Paragon Park in Nantasket Beach.

During that time, he also served as President of the New England Association of Amusement Parks and Attractions.

Hundreds and hundreds of Hull kids and many adults worked for him over the years and he was a great mentor and friend to them all.

After the park closed, he worked as a bank examiner for the Commonwealth of Massachusetts until his retirement.

He was president of the Hull Lions Club, was a member of the Committee for the Preservation of Hull's History, and was instrumental in the effort to preserve the Paragon Carousel for future generations.

He was also an active member of both Temple Beth Shalom and B'nai B'rith.

Myron is survived by his loving wife, Dorothy (Dodie), of sixty years; his son, Neil and daughter-in-law, Adrienne Brenner; son, Barry and daughter-in-law, Elyse Mall; and his daughter, Lisa and son-in-law, Neil Aronson.

He was the cherished Papa of Noah and Julia Klayman and of Jake and Benjamin Aronson.

Accordingly, as a mark of respect in memory of Myron Klayman, at seventeen minutes past eleven o'clock A.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
