JOURNAL OF THE SENATE.

Monday, June 13, 2016.

Met at twelve minutes past eleven o'clock A.M. (Ms. Forry in the Chair).

The Chair (Ms. Forry), members, guests and staff then recited the pledge of allegiance to the flag.

Communication.

Communication from the Department of Correction relative to a plan of correction and the anticipated date of completion of the repairs for the Capital Projects (received June 10, 2016),-- **was placed on file.**

Mr. Montigny, for the committee on Rules, to whom was referred the Senate Order relative to authorizing the joint committee on Public Health to make an investigation and study of certain current Senate documents relative to public health issues (Senate, No. 2199), reported, in part, a "Bill relative to the practice of athletic training" (Senate, No. 1216);

Read and, under Senate Rule 26, referred to the committee on Rules.

Mr. Montigny, for the committee on Rules, to whom was referred the Senate Order relative to authorizing the joint committee on the Judiciary to make an investigation and study of certain current Senate documents relative to judicial matters (Senate, No. 2204), reported, in part, a "Bill relative to privileged communications" (Senate, No. 812);

The House Bill increasing the membership of the board of health in the town of Framingham (House, No. 3977, amended) (its title having been changed by the committee on Bills in the Third Reading),-- **was read a third time and passed to be engrossed, in concurrence.**

Remarks of Minority Leader Bruce E. Tarr.

February 13, 2016 marked the one year anniversary of the passing of Michael A. Bulgaris of Byfield. He spent 40 years with the Protection Fire Company No. 1 in Byfield, MA. Mr. Bulgaris served the Fire Company in many different capacities, including Firefighter, Engineer, 2nd Lieutenant, 1st Lieutenant, Captain, and Vice-President. Of special note, was his service as President of Protection Fire Company No. 1 from 1985-2012. He was also an emergency medical technician working on an ambulance for many years assisting people on the frontlines of extremely distressing and stressful situations.

During his career in Byfield, Mr. Bulgaris served for several years on the Board of Fire Engineers for the Town of Newbury, and was a member of the Board of Selectmen when he died. He prided himself on being active with the Company's functions and fundraisers and was a mentor to countless younger members. His dedication and leadership have been sorely missed by his peers and the community.

On motion of Mr. Tarr, under the provisions of Senate Rule 6, the remarks were printed in the Journal of the Senate.

Reports of a Committee.

By Ms. Spilka, for the committee on Ways and Means, on petition (accompanied by bill, Senate, No. 1151), a Bill relative to the modernization of optometric patient care (Senate, No. 2334).

The bill was read. There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.

By Ms. Spilka, for the committee on Ways and Means, that the Senate Bill establishing a board of registration in naturopathy (Senate, No. 2148),-- ought to pass, with an amendment substituting a new draft with the same title (Senate, No. 2335) [Estimated cost: \$300,000].

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2335) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.

Remarks of Senator Linda Dorcena Forry.

Before we end today's session, I want to take a brief moment to address this tragedy, on behalf of Senate President Stan Rosenberg, Minority Leader Bruce Tarr and the Senate.

June is a month of Pride celebrations with our friends in the LGBT community. It is a month of joy and happiness in overcoming social inequality and to celebrate Love.

However, yesterday morning we woke to find that 50 innocent people were killed, and 53 others wounded, in a despicable act of hate and terror, while celebrating Pride in Orlando, Florida.

We stand together, as one community, in solidarity with our Gay and Lesbian family and friends, the families whose sons & daughters, granddaughters & grandsons, brothers & sisters, nieces & nephews who were killed and injured, and the people of Orlando.

Today we remember Stanley Manolo Almodovar III of Springfield, and KJ Morris formally of the Pioneer Valley, who lost their lives in this senseless act.

We pray for their families and are here to comfort those affected by this act of hatred.

We have gone to sleep too many nights, and woken up too many mornings to a new tragedy.

As we have before and will continue to do again, we will come together as a stronger more united country. We will never forget those we lost, but we will not be afraid to show our Pride. We ask God to give us the courage and strength to Stand Up to Hate.

On motion of Mr. Tarr, the remarks were ordered printed in the Journal of the Senate.
