JOURNAL OF THE SENATE.

Thursday, June 18, 2015.

Met at six minutes past eleven o'clock A.M. (Mr. DiDomenico in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. DiDomenico), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. DiDomenico) handed the gavel to Mr. Ross for the purpose of an introduction. Mr. Ross then introduced, in the rear of the Chamber, the third grade class from the Happy Hollow School in Wayland. The students were on a field trip to the State House learning about the different aspects of state government. The Senate welcomed them with applause and they withdrew from the Chamber.

Communications.

Mr. Lewis, for the committee on Public Health reported, asking to be discharged from further consideration Of the petition (accompanied by bill, Senate, No. 1120) of Harriette L. Chandler for legislation relative to requiring the licensure of persons engaged in the removal of body art;

Of the petition (accompanied by bill, Senate, No. 1126) of Harriette L. Chandler for legislation relative to body art and body piercing regulation; and

Of the petition (accompanied by bill, Senate, No. 1168) of Thomas P. Kennedy for legislation to modernize firm leadership structures;

And recommending that the same severally be referred to the committee on Consumer Protection and Professional Licensing;

Of the petition (accompanied by bill, Senate, No. 1166) of John F. Keenan, Brian M. Ashe and Mark J. Cusack for legislation relative to bed bugs,-- **and recommending that the same be referred to the committee on Housing;**

Of the petition (accompanied by bill, Senate, No. 1116) of William N. Brownsberger, Sarah K. Peake, Chris Walsh, Harriette L. Chandler and other members of the General Court for legislation to establish civil and criminal penalties for the female genital mutilation of minors,-- **and recommending that the same be referred to the committee on the Judiciary;**

Of the petition (accompanied by bill, Senate, No. 1211) of Michael J. Rodrigues for legislation to provide training for certain local boards and commissions,-- **and recommending that the same be referred to the committee on Municipality and Regional Government; and**

Of the petition (accompanied by bill, Senate, No. 1198) of Michael O. Moore, Leonard Mirra, Timothy R. Whelan, Leah Cole and other members of the General Court relative to firearm license fees,-- **and recommending that the same be referred to the committee on Public Safety and Homeland Security;**

Petition (accompanied by bill, House, No. 3587) of Sarah K. Peake (by vote of the town) that the town of Provincetown be authorized to increase exemptions for residential properties in said town;
Petition (accompanied by bill, House, No. 3588) of Sarah K. Peake (by vote of the town) that the town of Wellfleet be authorized to establish a room occupancy tax on vacation rentals; and
Petition (accompanied by bill, House, No. 3589) of Sarah K. Peake (by vote of the town) that the town of Chatham be authorized to use revenue from the boat excise tax for waterway improvement fund purposes;

Matters Taken Out of the Orders of the Day.

The House Bill authorizing the town of Montague to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises (House, No. 3370),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

The House Bill authorizing the town of Montague to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (House, No. 3374),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

Reports of Committees.

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Anthony W. Petruccelli for legislation to revitalize the Commonwealth's waterfronts.
The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Environment, Natural Resources and Agriculture.

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of John F. Keenan and Tackey Chan for legislation to establish a sick leave bank for Susan Welliver, an employee of the Massachusetts Department of Transportation.
The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Severally sent to the House for concurrence.

Emergency Preambles Adopted.

An engrossed Bill establishing a sick leave bank for Denise Dellagrotte, an employee of the Trial Court (see Senate, No. 1933), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency

preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0. The bill was signed by the Acting President (Mr. DiDomenico) and sent to the House for enactment.

An engrossed Bill establishing a sick leave bank for Kim Quitadamo, an employee of the Trial Court (see House, No. 3348), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0. The bill was signed by the Acting President (Mr. DiDomenico) and sent to the House for enactment.

An engrossed Bill establishing a sick leave bank for Thomas J. Doucette, an employee of the Department of Correction (see House, No. 3358), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0. The bill was signed by the Acting President (Mr. DiDomenico) and sent to the House for enactment.
