### JOURNAL OF THE SENATE.

Thursday, June 25, 2015.

Met at three minutes past eleven o'clock A.M. (Ms. Lovely in the Chair).

#### *Communication.*

Communication from the Honorable Stanley C. Rosenberg, President of the Senate announcing the appointment of Senator Michael F. Rush (pursuant to Section 214 of Chapter 6 of the General Laws) to serve on the Madeline Amy Sweeney Award Selection Committee,-- **was placed on file.**
