### JOURNAL OF THE SENATE.

*Tuesday, July 28, 2015.*

Met at five minutes past eleven o'clock A.M.

The Senator from Plymouth and Barnstable, Mr. deMacedo, led the President, members, guests and staff in the recitation of the pledge of allegiance to the flag.

#### *Reports of Committees.*

By Mr. Timilty, for the committee on Public Service, on petition, a Resolve relative to an investigation and study by a special commission relative to the civil service exam (Senate, No. 1427);

**Read and, under Joint Rule 29, referred to the committees on Rules of the two branches, acting concurrently.**

By Mr. Timilty, for the committee on Public Service, on Senate No. 1400 and House No. 2359, a Bill to further regulate group insurance benefits for state employees and retired state employees (Senate, No. 1400); and

By Mr. McGee, for the committee on Transportation, on petition, a Bill relative to vehicle idling (Senate, No. 1853);

**Severally read and, under Senate Rule 27, referred to the committee on Ways and Means.**

By Mr. McGee, for the committee on Transportation, on petition, a Bill to designate a certain bridge in the city of Westfield as the All Westfield Patriots Bridge (Senate, No. 1839);

By the same Senator, for the same committee, on petition, a Bill to designate a certain bridge in the town of Norwood as the Thomas J. Kewriga Memorial Bridge (Senate, No. 1871); and

By the same Senator, for the same committee, on petition, a Bill relative to a bridge in Barre (Senate, No. 1952);

*Order Adopted.*

*Ordered*, That notwithstanding Senate Rule 7 or any other rule to the contrary, the Senate Bill clearing titles to foreclosed properties (Senate, No. 882) (the committee on Ways and Means having recommended that the bill be amended by substituting a new draft, Senate, No. 1981) shall be placed in the Orders of the Day for a second reading on Wednesday, July 29, 2015.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 3:00 P.M., on Wednesday, July 29, 2015. All such amendments shall be second-reading amendments to the recommended Senate Ways and Means new draft (Senate, No. 1981) but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.
