JOURNAL OF THE SENATE.

Thursday, September 15, 2016.

Met at ten minutes past eleven o'clock A.M.

The Senator from Essex and Middlesex, Mr. Tarr, then led the President, members, guests and staff in the recitation the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the President handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, Wisconsin State Senator Leah Vukmir. Senator Vukmir is the Assistant Majority Leader and represents Senate District 5. The Senate welcomed her with applause and she withdrew from the Chamber.

There being no objection, the President handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, a group of students from St. Kevin's College in Melbourne, Australia. The group was on a tour of the State House learning about the different aspects of state government. The Senate welcomed them with applause and they withdrew from the Chamber. The students were accompanied by Andrew Butcher, Vince Toohey and Bob Windle. They were the guests of Senator Tarr and Representative Hill of Ipswich.

Communications.

study of a certain current Senate document relative to veteran property tax (Senate, No. 2487),-- **and recommending that the
same be referred to the committee on Rules;
Under Senate Rule 36, the report was considered forthwith and accepted.**

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:
The House Bill establishing a 4-year term for the office of mayor in the city known as the town of West Springfield (House, No.
4433),-- **was read a third time and passed to be engrossed, in concurrence.**

PAPER FROM THE HOUSE
Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Jose Valencia, an employee of the Department of Mental Health (see House,
No. 4579), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an
emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of
Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.
The bill was signed by the President and sent to the House for enactment.

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The Senate Bill authorizing the town of Warren to continue the employment of Dennis Desrosiers (Senate, No. 2319),-- **was read
a third time and passed to be engrossed.
Sent to the House for concurrence.**

The House Bill relative to the town of Mattapoisett general by-laws (House, No. 3924),-- **was read a third time and passed to
be engrossed, in concurrence.**

The House Bill exempting certain positions in the city of Marlborough from the civil service law (House, No. 4337),-- **was read
a third time and passed to be engrossed, in concurrence.**

The Senate Bill to create a department of municipal finance in the town of Carver under the direction of a finance director (Senate, No. 2460),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.**

The House Bill relative to the procedure for municipal acceptance of subdivision roads in the town of Natick (House, No. 4446, changed),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

Report of a Committee.

Mr. Montigny, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill designating a certain bridge in the city of Fall River as the Tom Tetrault Bridge (Senate, No. 2480). **There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.**

PAPERS FROM THE HOUSE.

A Bill providing that future members of the police force of the town of Sharon shall be exempt from the provisions of the civil service law (House, No. 4338,-- on petition) [Local approval received],-- was read. **There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.**

A Bill authorizing the town of Foxborough to grant 4 additional licenses for the sale of all alcoholic beverages to be drunk on the premises within a site containing a development to be known as Route One (House, No. 4609,-- on House, No. 4429) [Local approval received on House, No. 4429],-- was read. **There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.**

Engrossed Bills.

The following engrossed bills (the first of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to enacted and were signed by the President and laid before the Governor for his approbation, to wit:

Establishing a parks and recreation committee in the town of Becket (see Senate, No. 2224);
Establishing a 4-year term for the office of mayor in the city known as the town of West Springfield (see House, No. 4433); and
Establishing a sick leave bank for Jose Valencia, an employee of the Department of Mental Health (see House, No. 4579).
