### JOURNAL OF THE SENATE.

*Thursday, December 3, 2015.*

Met at nine minutes past eleven o'clock A.M. (Mr. DiDomenico in the Chair).

The Chair (Mr. DiDomenico), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Distinguished Guests.*

There being no objection, the Chair (Mr. DiDomenico) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, Ronald and Charles Masiello, co-owners of Crystal Motor Express, Inc. The Senate welcomed them with applause and they withdrew from the Chamber.
