### JOURNAL OF THE SENATE.

*Monday, December 21, 2015.*

Met at ten minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Report.*

Report of the Merrimack Valley Regional Transit Authority (pursuant to Section 8(g) of Chapter 161B of the General Laws) submitting its annual report for the fiscal year 2015 (received December 18, 2015),-- **was placed on file.**
