Met at four minutes past eleven o'clock A.M. (Mr. Petruccelli in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Petruccelli), members, guests and staff then recited the pledge of allegiance to the flag.

On motion of Mr. Tarr, the above communication was ordered printed in the Journal of the Senate.

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The House Bill relative to the sale of all alcoholic beverages in certain establishments in the town of Stoneham (House, No. 3375, amended),-- was read a third time and passed to be engrossed, in concurrence.

The House Bill authorizing the town of Bedford to grant 8 additional licenses for the sale of all alcoholic beverages to be drunk on the premises (House, No. 3802) (its title having been changed by the committee on Bills in the Third Reading),-- was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Barrett presented an amendment in section 1 by striking out subsections (b) to (d), inclusive, and inserting in place thereof the following 3 subsections:-

- "(b) The licensing authority may restrict the licenses issued pursuant to this act to holders of common victualler licenses.
- (c) Once issued, the licensing authority shall not approve the transfer of a license granted pursuant to this act to any other location but it may grant a license to a new applicant at the same location if the applicant files with the licensing authority a letter from the department of revenue and a letter from the department of unemployment assistance indicating that the license is in good standing with those departments and that all applicable taxes, fees and contributions have been paid.
- (d) If a license granted pursuant to this act is cancelled, revoked or no longer in use, it shall be returned physically, with all of the legal rights, privileges and restrictions pertaining thereto, to the licensing authority and the licensing authority may then grant the license to a new applicant under the same conditions as specified in this act."

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment. Sent to the House for concurrence in the amendment.

Report of a Committee.

Mr. Montigny, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill authorizing the merger of the Annawon Council, Inc. and the Boy Scouts of America into the Narragansett Council, Boy Scouts of America (Senate, No. 2041).

There being no objection, the rules were suspended, on motion of Mr. Tarr and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act authorizing the merger of the Annawon Council, Inc., Boy Scouts of America into the Narragansett Council, Boy Scouts of America."

Sent to the House for concurrence.

PAPERS FROM THE HOUSE.

The Senate Bill authorizing the town of Chelmsford to hold licenses for the sale of all alcoholic beverages to be drunk on the premises (Senate, No. 1924),-- came from the House passed to be engrossed, in concurrence with an amendment in section 1 by striking out subsections (b) and (c) and inserting in place thereof the following 2 subsections:-

- "(b) Notwithstanding section 17 of chapter 138 of the General Laws, the licensing authority of the town of Chelmsford may grant to the town hall advisory committee of the town of Chelmsford a license for the sale of all alcoholic beverages to be drunk on the premises at 1A North road pursuant to section 12 of said chapter 138. The license shall be subject to all of said chapter 138 except said section 17.
- (c) Notwithstanding section 17 of chapter 138 of the General Laws, the licensing authority of the town of Chelmsford may grant to the north town hall advisory committee of the town of Chelmsford a license for the sale of all alcoholic beverages to be drunk on the premises at 31 Princeton street in said town pursuant to section 12 of said chapter 138. The license shall be subject to all of said chapter 138 except said section 17.".

The rules were suspended, on motion of Mr. Tarr and the House amendment was considered forthwith and adopted, in concurrence (as corrected BTR).

A petition (accompanied by bill, House, No. 3921) of Diana DiZoglio and Kathleen O'Connor Ives for legislation to establish a sick leave bank for Brian Sheehan, an employee of the Middlesex Sheriff's Office,-- was referred in concurrence, under suspension of Joint Rule 12, to the committee on Public Service.

Engrossed Bill.

An engrossed Bill designating the 2nd Sunday in June annually as Massachusetts Race Amity Day (see House, No. 2745, amended) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Petruccelli) and laid before the Governor for his approbation.

Ordered, That when the Senate adjourns today, it adjourn to meet again on Monday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.
