Adjourn In Memory of Councilor William A. Toomey.

The Senator from Essex, Ms. Lovely, moved that when the Senate adjourns today, it adjourn in memory of Peabody Councilor William A. Toomey.

William A. “Bill” Toomey, a longtime member of the Peabody City Council, died unexpectedly on Sunday, July 23, 2017, at the age of 84.

Born in Salem, Massachusetts on July 28, 1932, he was the son of the late George L. And Helen (Keyhole) Toomey and had resided in Peabody for most of his life.

Bill was a veteran of the United States Army, serving in the Korean War. Upon his discharge in 1954, he entered Merrimack College where he received a bachelor’s degree. He was first employed at the General Electric Company in Lynn, and later at GTE Sylvania where he was a purchasing agent in the Needham plant for 20 years prior to his retirement 25 years ago.

Bill was very active in political and civic organizations in Peabody, serving on the Peabody City Council for 26 years. He was also a member and current President of the Friends of the Peabody Council on Aging, and was a Vice-Chairman of the Peabody Council on Aging.

Bill enjoyed being the host of the senior corner on Peabody access TV. He

drove a bus for many years for Catherine's Day Care Center in Peabody and was a vendor for 15 years at the Todd Farm Flea Market in Rowley. Bill had been a member of the A.O.H. Division 11 of Peabody, Leo Council Knights of Columbus, and Portuguese American War Veterans Post 1 of Peabody.

Bill's years of service on the Peabody City Council will never be forgotten. He will always be remembered for his two-plus decades of dedicated service to the city that he loved so dearly.

Bill is survived by his wife, Elizabeth; a son and daughter-in-law, William A. and Barbara Toomey of Sandy Hook, Connecticut; a daughter and son-in-law, Ellen Toomey Manning and Michael Manning of Byfield, Massachusetts; his grandchildren, Sierra and Kai Toomey of Connecticut, and Jameson and Finnegan Manning of Byfield; and many nieces and nephews. He was the brother of the late Leo Toomey.
