JOURNAL OF THE SENATE.

Monday, August 28, 2017.

Met at three minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

There being no objection, the Chair (Mr. Brownsberger) handed the gavel to Mr. Ross for the purpose of an introduction. The Senate welcomed them with applause and they withdrew from the Chamber.

*Order Adopted.*

Mr. Rosenberg offered the following order, to wit:

*Ordered,* That by the authority of article IV of section II of chapter I of the Constitution, the Senate declares that, by reason of the resignation of Jennifer L. Flanagan as senator from the Worcester and Middlesex district effective at the end of business on August 31, 2017, the office of senator from the Worcester and Middlesex district is vacant. By the authority of article XXIV of the Amendments to the Constitution, the Senate directs the president of the Senate to issue a precept setting forth December 5, 2017, as the day for holding an election to fill the vacancy in the Worcester and Middlesex district, comprising of the cities of Fitchburg, Gardner and Leominster and the towns of Berlin, Bolton, Clinton, precincts 1 and 2, Lancaster, Lunenburg, Sterling and Westminster in the county of Worcester; and the town of Townsend in the county of Middlesex.

**Subsequently, Mr. Montigny, for the said committee, reported, recommending that the order ought to be adopted.**

**The rules were suspended, on motion of Ross, and the order was considered forthwith and adopted, by a vote of 2 to 0.**

*Engrossed Bills.*

The following engrossed bills (the first of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Brownsberger) and laid before the Governor for his approbation, to wit:

Authorizing the city of Boston to grant 15 additional licenses for the sale of alcoholic beverages to be drunk on the premises (see House, No. 3757, amended).

An engrossed Bill relative to the annual town election in the town of Rockport (see House Bill, printed in House, No. 3656) (which originated in the House), **having been certified by the Senate Clerk to be rightly and truly prepared for final passage was passed to be enacted, two-thirds of the members present having voted in the affirmative, and signed by the Acting President (Mr. Brownsberger) and laid before the Governor for his approbation.**
