Monday, October 16, 2017.

Met at nine minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

*Ordered,* That notwithstanding any rule to the contrary, there shall be a special senate committee on health care cost containment and reform, consisting of the senate chair of the joint committee on health care financing, who shall chair the special committee, the senate majority leader, the chair of the senate committee on ways and means, the senate chair of the joint committee on public health, the senate vice-chair of the joint committee on mental health, substance abuse and recovery, and a member of the senate appointed by the minority leader. The special committee shall receive a report, including draft legislation, by the senate working group on health care cost containment. The clerk shall publicly post the report on the legislative website. The special committee shall conduct a public hearing on the report and the accompanying draft legislation on Monday, October 23<sup>rd</sup>, and shall report legislation to the committee on Ways and Means (Senate, No. 2180).

*Adjourn In Memory of Attorney Stephen J. Phillips.*

The Senator from Hampden and Hampshire, Mr. Lesser, moved that when the Senate adjourns today, it does so in memory of Attorney Stephen J. Phillips of Longmeadow, a well-known criminal defense lawyer, who died on Wednesday, September 20, 2017 after a prolonged and courageous battle with cancer.

Stephen, known fondly as “BoBo”, was born in Springfield and was a graduate of Cathedral High School, class of 1976. He graduated from Westfield State College and earned his law degree from Western New England School of Law. Stephen was a passionate and determined attorney with Dunn & Phillips, PC.

Stephen received the Access to Justice Pro Bono Publico Award from the Massachusetts Bar Association in 2014 for his free legal assistance to hospice patients, during a dinner in Boston that also honored Boston Mayor Martin Walsh.

In 2015, he was honored with the prestigious Saint Thomas More Distinguished Lawyer award in recognition of his public service.

Stephen left a strong impact on his community and a lasting impression on everyone he met. He was an effective and diligent volunteer with the Baystate Visiting Nurse Association & Hospice.

Stephen was recognized for the free legal assistance he provided to 130 hospice patients through Baystate Visiting Nurse Association & Hospice over the course of 13 years. A letter supporting his nomination praised him for "always being there for patients -- no matter what."

His assistance to hospice patients was described as involving "everything from drafting wills to counseling on end-of-life matters. But sometimes his greatest work [came] when he just [spent] time with them to watch a Red Sox/Yankee game."

Stephen is survived by his loving wife of 34 years and best friend Zita, his children Stephen J. Phillips Jr. of Springfield, Paul Phillips of Longmeadow and his fiancé Tara, Brian Phillips and Briana of Longmeadow, Michael Phillips and Liz of Washington, D.C., and his youngest Katie McGowen of Longmeadow and her husband Scott. He also leaves behind his four legged best friend, Fairfield, who never left his side. He also leaves his six siblings and their spouses, Neil and Kathy Phillips, Gerald Phillips, Kevin Phillips, Mary Phillips, Liz and Jim Fortsch, and Joe and Karen Phillips.

Stephen will be remembered for his many contributions to the community including working as a youth sports volunteer, which included weekly mowings of the field hockey field for his daughter's team. His love of hockey, vacations on Cape Cod, and family gatherings at his home brought him great joy over the years. He was a wonderful husband, an incredible father, and a loyal friend.

Accordingly, as a mark of respect in memory Stephen J. Phillips, at twenty-eight minutes past eleven o'clock A.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Thursday next at eleven o'clock A.M.
