*Ordered,* That by the authority of article IV of section II of chapter I of the Constitution, the Senate irrevocably accepts the resignation of Thomas M. McGee as senator from the Third Essex district, dated November 13, 2017 and effective as of 6:59 P.M. on January 2, 2018, and declares that, by reason of this resignation, the office of senator from the Third Essex district is vacant as of January 2, 2018 at 6:59 P.M. By the authority of article XXIV of the Amendments to the Constitution, the Senate directs the president of the Senate to issue a precept setting forth March 6, 2018, as the day for holding an election to fill the vacancy in the Third Essex district, comprising of the city of Lynn and the towns of Lynnfield, Marblehead, Nahant, Saugus and Swampscott in the county of Essex.
