Nellie lived in Chicopee for 68 years, where she was an active member of the

community. She was a communicant of St. Stanislaus Basilica, where she was a member of the church's Rosary Society. Nellie was known for her delicious pierogis and served as her parish's pierogi-maker, most notably during the annual St. Stan's Bazaar.

Nellie was a graduate of Springfield's Technical High School. She worked at Our Lady of the Elms College for 28 years and served as a "noon mother" in the Chicopee Public Schools. Nellie was also a member of, and financial secretary for, the Polish Women's Alliance, Group 317.

Nellie was predeceased by her husband Joseph J. Pise. She is survived by her six loving children, Joseph J. Pise, Jr. of Chicopee; Linda M. Green and her husband James of Pompey, New York; Attorney Michael J. Pise of Chicopee; James M. Pise of Clifton, New Jersey; Cynthia A. Masison and her husband Daniel of Bethesda, Maryland; and Christine Pise of Chicopee.
