JOURNAL OF THE SENATE.

Monday, December 11, 2017.

Met at six minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the Acting President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Emergency Preamble Adopted.

An engrossed Bill designating a certain bridge in the town of Auburn and a portion of state highway in the town of Leicester in memory of Officer Ronald Tarentino, Jr. (see Senate, No. 2193, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an

emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Brownsberger) and sent to the House for enactment.

Adjourn In Memory of Nelson R. "Ray" Dionne

The Senator from the Hampden and Hampshire, Mr. Humason, moved that when the Senate adjourns today, it do so in memory of Nelson R. "Ray" Dionne of Westfield.

Mr. Humason in the Chair, on November 12, 2017, Ray passed away at the age of 81.

Born in Fort Kent, Maine to the late Omer and Mable (Pelletier) Dionne, Ray graduated from Fort Kent Community High School in 1954.

Shortly thereafter, Ray enlisted in the United States Army to serve his country during the Korean War from 1954-1956. He received an honorable discharge from the Army with the rank of Specialist Third Class (SP3). He was a true patriot and loved his country.

Following his military service, Ray completed a 33 year career as a machinist at Advance Manufacturing in Westfield.

In addition to devoting much of his time to his cherished family, Ray was an active and much-beloved member of the Westfield community. As a member of the Hampton Ponds Association, he was often found on the water tending to the needs of the ponds, his neighbors, and his fellow boaters. Ray was also a long-time member of the Westfield Sportsmen Club, life member of the National Rifle Association, and a proud advocate for the 2nd Amendment.

Ray was predeceased by his beloved wife of 57 years, Jean A. (Ezold) Dionne in 2015 as well as three sisters, Reinette Deschine, Joella Deprey and Dora-Jean Michaud. He is survived by his two loving sons, Raymond A. Dionne of Westfield and Robert A. Dionne and his wife Karen of Holyoke, his brother Joseph R. Dionne and his wife Lorraine of Westfield, a sister Dora-Mae Voisine of Chicopee, his cherished five grandchildren, Melanie, Stephanie and her husband Roger, Amanda Jean, Cody and Tanner and three great grandchildren, Mya, Skye and Ayden.
