

Matters Taken Out of the Orders of the Day.

The House Bill exempting all positions in the fire department of the town of Plainville from the civil service law (House, No. 3864),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act exempting all uniformed positions in the fire department of the town of Plainville from the civil service law".

The House Bill authorizing the town of Swampscott to grant additional licenses for the sale of alcoholic beverages to be drunk on the premises (House, No. 3931),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act authorizing the town of Swampscott to grant 8 additional licenses for the sale of all alcoholic beverages to be drunk on the premises".

Pending the question on ordering the bill to a third reading, Mr. Lewis presented an amendment in section 1, by striking out, in lines 13 and 14, the words "the city council may choose an alternate date to fall within the first 8 days of the year" and inserting in place thereof the following words:- "the oath required shall be administered on the first Tuesday of that year".

The amendment was adopted.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act further regulating the administration of the oath of office of members of the city council and school committee in the city of Malden".

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Rosibel Umanzor, an employee of the Department of Public Health (see House, No. 4007, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 5 to 0.

By Ms. Spilka, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Elizabeth O'Brien, an employee of the Department of the Attorney General (Senate, No. 2176),-- ought to pass, with an amendment by striking out, in line 6, the words "department paid" and inserting in place thereof the following words:- "extended illness"; and by inserting before the enacting clause the following emergency preamble:-

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of the attorney general, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

There being no objection, the rules were suspended, on motion of Ms. Lovely, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2176, amended), was then ordered to a third reading, read a third time and passed to be engrossed.

The Senator from Essex, Ms. Lovely, moved that when the Senate adjourns today it adjourn in memory of Daniel F. Pimenta of Peabody.

Daniel F. Pimenta died unexpectedly at the age of 53. He was the devoted husband of Donna (Chouinard) Pimenta with whom he shared over 28 years of marriage.

Born in Beverly, he was the son of Antonio Pimenta of Peabody, and the late Florence (Abbondanza) Pimenta. He was a lifelong resident of Peabody and graduate of Peabody Veterans Memorial High School, Class of 1982. He also attended Bridgewater State College. Dan was an outstanding athlete in high school and was a running back on the Varsity football team. He later coached the freshman football and the jayvee lacrosse teams for Peabody, and he coached youth lacrosse as well.

Dan was a firefighter for the city of Peabody for over 27 years. Dan enjoyed cooking, spending time with his family, and was an avid cyclist, which helped him with his multiple sclerosis and was his way of giving back to the MS community.

Besides his loving wife, Dan is survived by his children, Jake and Stephanie Pimenta, both of Peabody; his siblings, Joseph Pimenta of Falls Church, Virginia, Michael Pimenta of New Boston, New Hampshire, Madeline "Maddie" Pimenta of Peabody, and Lisa LaForge of Essex. He is also survived by several nieces and nephews and a very special great nephew, Mason Kierstead of Peabody, whom he taught how to ride a bike, and shared a special bond. He was predeceased by his brother, David A. Pimenta.
