Monday, December 4, 2017.

Met at eighteen minutes past one o'clock P.M. (Mr. Pacheco in the Chair).

The Chair (Mr. Pacheco), members, guests and staff then recited the pledge of allegiance to the flag.

Suspension of Senate Rule 38A.

Mr. Tarr moved that it be the sense of the Senate that the vote for Harriette L. Chandler for Acting President should be made unanimous and that this expression of opinion be made a part of the records of the Senate.

There being no objection, this motion was entertained; and it was unanimously adopted.

Ms. Chandler was escorted to the Chair by Senators Creem of Middlesex and Norfolk and Montigny of Bristol and Plymouth.

*Remarks of Acting President Harriette L. Chandler*

The Acting President then addressed the Senate as follows:

Thank you so much to my colleagues, both Republicans and Democrats for giving me this privilege to lead our Body. The past 4 days, as I've said before, have been so turbulent, so tragic, so surprising, and so sad. I wish I could look at this wonderful election that you have given me in joy rather than the way I feel and I think I speak for all of us. I wish this were a time for celebration, but it truly isn't a time for celebration for me. The circumstances that have led to this election are unprecedented and unfortunate. But choices had to be made, and you my colleagues have risen to the occasion and you have gone forward, you have chosen to move on, and to move forward. The hour is late and I do not wish to take this time and use to it to just add more thinking, we've done a lot of talking today, these last almost 8 hours. And we as a caucus and as a body will work swiftly toward a return to regular order. I promise you that. I promise to give you the very best of my ability. And I thank you for this incredible honor. I thank you for making this a bi-partisan effort, that means a great deal to me, and I thank you.

The special investigator shall have full access to the President's office and the full cooperation of his staff. The Senate Committee on Ethics is authorized to require by summons the attendance and testimony of witnesses and the production of books and papers and such other records as the Committee may deem relevant.
