After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

PAPERS FROM THE HOUSE.

The Senate Bill authorizing the Berkshire County Regional Housing Authority to convey a certain parcel of land in the town of Sheffield to the Great Barrington Housing Authority (Senate, No. 2102),-- came from the House passed to be engrossed, in concurrence *with an amendment*, in section 1, in lines 1 to 10, inclusive, by striking out the paragraph contained in those lines and inserting in place thereof the following paragraph:

Sheffield,-- land conveyance.

“SECTION 1 (a) Notwithstanding chapter 121B of the General Laws and subject to approval by the department of housing and community development, the Berkshire county regional housing authority may convey a certain parcel of land, currently used for low income housing subject to said chapter 121B, with the buildings thereon, identified by the department of housing and community development as project reference numbers 705-2 and 667-2, located in the town of Sheffield to the Great Barrington housing authority for no consideration. The parcel is described in a deed recorded in the Southern Berkshire registry of deeds in book 660, page 186. The buildings shall remain subject to said chapter 121B and the property shall be used to provide additional housing for low-income families and elderly persons of low income, in accordance with said chapter 121B and the regulations of the department of housing and community development.”

The rules were suspended, on motion of Mr. Rosenberg, and the House amendment was considered forthwith and adopted, in concurrence.

The amendment was adopted.

Mr. O'Connor moved that the proposed new text be amended by inserting in line item 1100-3005 the following:- “provided further, that \$3,000,000 shall be expended to support renovations to the town hall building in the town of Hingham”. 10

The amendment was adopted.

Mr. O'Connor moved that the proposed new text be amended by inserting in line item 1100-3005 the following:- “provided further, that \$3,000,000 shall be expended to the town of Weymouth to support improvements to the department of public works facilities”. 11

public counsel services, 1 member of the senate appointed by the senate president, and 1 member of the house of representatives appointed by the speaker; provided further, that the special commission shall: (i) evaluate whether such sites are appropriate to adjoin facilities to house related criminal justice functions, including courts, pre-arraignment lock-up facilities, and a female lock-up facility, and (ii) analyze the current inmate and detainee populations in the county and make recommendations on the appropriate scale of any new facility based upon that analysis and make recommendations on whether the future inmate and pretrial detainee population within the county may be reduced; provided further, that the special commission shall report its findings and recommendations to the governor and the clerks of the house of representatives and the senate not later than January 1, 2019”.

Ms. Chang-Diaz moved that the proposed new text be amended in section 2, in line item 7066-2018, by inserting after the words “Cape Cod Community College”, in line 94, the following words:- “; provided further, that \$3,600,000 shall be expended for infrastructure upgrades at Roxbury Community College”. 26

Ms. Chang-Diaz moved that the proposed new text be amended in section 2, in item 8000-3502, by inserting after the word “Medford”, in line 127, the following words:- “; provided further, that \$1,000,000 shall be expended for the design and construction of a new fire station at Engine 42 in the Roxbury neighborhood of the city of Boston”. 27

The amendment was adopted.

Mr. Boncore moved that the proposed new text be amended in section 2, in item 8000-3502, by inserting after the word “Medford”, in line 126 the following words:- “provided, further, that \$7,500,000 shall be expended for the study, design and construction of a fire station in the town of Winthrop”. 29

The amendment was adopted.

Mr. Boncore moved that the proposed new text be amended in section 2B, in item 1100-3005, by inserting after the word “Boston”, in line 217 the following words:- “provided further, that \$1,000,000 shall be expended to support renovations to the Paris street community center pool in the city of Boston”. 30

The amendment was adopted.

Messrs. Rush and Ross moved that the proposed new text be amended in line item 8000-3502 by adding at the end thereof the following:- “provided further, that \$2,000,000 shall be expended to support public safety communications infrastructure improvements in the town of Needham”. 31

Mr. Rush moved that the proposed new text be amended in section 2, in item 1102-2017, by adding the following words:- “; and provided further, that \$8,000,000 shall be expended for the construction of a regional ice skating rink and recreation center in the town of Norwood”. 32

“Section XX. Ms. Gobi moved that the proposed new text be amended by inserting, in line item 8000-3502, the following words:- “provided further, that \$6,000,000 shall be expended for the design, renovation, addition and construction of a public safety complex in the town of Ashby”. 157

The amendment was adopted.

Ms. Gobi moved that the proposed new text be amended by inserting, in line item 1100-3005, the following words:- “provided further, that \$5,000,000 shall be expended for the design and construction of a public works building in the town of Palmer”. 158

The amendment was adopted.

Messrs. Timilty and Keenan moved that the proposed new text be amended by adding in section 2, item 1102-2017 the following:- “provided that \$500,000 shall be expended for repairs to the Blue Hills Trailside Museum building; and provided that \$750,000 shall be expended for upgrades and repairs to the otter exhibit located at the Blue Hills Trailside Museum”. 159

The amendment was *rejected*.

Ms. Gobi moved that the proposed new text be amended by inserting, in line item 1100-3005, the following words:- “provided further, that \$1,000,000 shall be expended for construction of a senior center in the town of Brimfield; provided further, that \$4,000,000 shall be expended for the planning and construction of a senior center in West Boylston”. 160

vocational schools, community colleges and other institutions and needs associated with advanced manufacturing programs; and (v) the consideration of future and current employer demands when projecting future funding needs. The report shall be conducted in collaboration with employers, vocational-technical schools and vocational-technical education stakeholders and shall be completed not later than July 1, 2018. The report shall be filed with the clerks of the senate and house of representatives and the chairs of the joint committee on education and the joint committee on economic development and emerging technologies”.

The amendment was adopted.

The President in the Chair, at one minute before three o'clock P.M, Mr. Tarr doubted the presence of a quorum; but a quorum was deemed present

Quorum.

Mr. Timilty moved that the proposed new text be amended by adding the following section:-

The inspector general shall prepare a report of his review and approval of the appraisal and file the report with the commissioner of capital asset management and maintenance, and copies of the same shall be filed with the house and senate committees on ways and means and the chairmen of the joint committee on state administration and regulatory oversight at least 15 days prior to the execution."

SECTION XXXX. Chapter 82 of the Acts of 2014 is hereby amended by striking out Section 3 and inserting in place thereof the following section: “Section 3. A signed TR1 form shall not be required to complete the conveyance of land authorized by this act.”

The amendment was *rejected*.

Ms. Spilka moved that the proposed new text be amended in section 2A, by striking out, in line 164, the word “renovations” and inserting in place thereof the following words:- “a feasibility study, the design, renovations”;

Adjourn In Memory of Gus Schumacher

The Senator from Cape and Islands, Mr. Cyr, moved that when the Senate adjourns today, it adjourn in memory of Gus Schumacher of Orleans.

Mr. Cyr in the Chair, Mr. Schumacher passed away of a heart attack on September 24th. He was 77 years old.

Mr. Schumacher was a devoted public servant and among the loudest voices for food justice not solely in the Commonwealth but nationwide. After growing up working on his family's farm, Mr. Schumacher was shocked when he met a mother in Boston who struggled to feed her kids healthy, balanced meals.

From there, his life's work began first in studies at Harvard College, the London School of Economics, and Harvard Business School before becoming Massachusetts Commissioner of Food and Agriculture. As commissioner, he pioneered federal and state partnerships to expand access to affordable healthy foods, and several programs that he oversaw in their infancy now make up a large portion of government food assistance nationwide.

During his time in state government, Mr. Schumacher was known to chide restaurateurs about the sources of their produce, constantly encouraging reliance on local sources as an early genesis of the farm-to-table movement.

Following his tenure as Commissioner, Mr. Schumacher went on to work at the World Bank and as undersecretary at the U.S. Department of Agriculture, bringing his ideas about food justice to the nation and world. In 2007 he returned to New England to co-found Wholesome Wave, a nonprofit dedicated to increasing affordable access to nutritional food options. He helped grow Wholesome Wave into a powerful catalyst for partnerships between producers and retailers to provide fresh produce at lower costs. Throughout his later years, he remained an active member on several boards and within the National Academy of Sciences, never turning down an opportunity to make a difference.

Mr. Schumacher is survived by his wife of 25 years, Susan Holaday Schumacher, stepdaughter Valerie Karasz, and two grandchildren.

Mr. Schumacher leaves behind a loving family and countless friends and colleagues who are sorrowed by his loss. He was a passionate activist and model public servant, and his work has contributed to what is now a worldwide food justice movement. May we all reflect on and appreciate Mr. Schumacher's life and legacy as we mourn with those who knew and loved him.
