PAPERS FROM THE HOUSE.

The House Bill making appropriations for fiscal year 2018 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 4160),-- came from the House with the endorsement that the House had NON-concurred with the Senate in its amendment striking out the emergency preamble and concurred with the Senate in its amendment striking out all after the enacting clause and inserting in place thereof the text of Senate, No. 2280 *with a further amendment* striking out all after the enacting clause and inserting in place thereof the text contained in House, No. 4242.

Supplemental appropriations.

**The rules were suspended, on motion of Mr. Tarr; and, on further motion of the same Senator, the Senate receded from its amendment striking out the emergency preamble and concurred with the House further amendment.**

*Emergency Preamble Adopted.*

An engrossed Bill making appropriations for fiscal year 2018 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4160, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Supplemental budget.

**The bill was signed by the President and sent to the House for enactment.**

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the

Senate adjourns today, it do so in memory of Donald Sudbay Sr., who passed away at the age of 90 on February 5, 2018, surrounded by his loving family.

Donald Sudbay was born in Gloucester on April 10, 1927, and was the son of the late James A. and Margaret M. Sudbay. He enlisted in the Navy during World War II, and had returned to Gloucester after the war to earn his high school diploma from Gloucester High School.

Don enjoyed a prosperous career in the automotive industry, which he entered in 1949. He had quickly risen through the ranks, and in 1965 started Sudbay Chevrolet Cadillac Buick, which celebrated its 50<sup>th</sup> year in business in 2015. He was known locally as “The Gentleman of the Automotive Business.”

Don had been an active member of the Gloucester community for many years, being a 59-year long member of the Gloucester Rotary Club, as well as a trustee for the Addison Gilbert Hospital for many years. He also served as a trustee for Cape Ann Savings Bank for 50 years, and received the “Small Business Person of the Year” award from the Cape Ann Chamber of Commerce in 1984.

In his 66 years of marriage with Phyllis Sudbay, the two enjoyed an active life with their children. He is survived by his children Donald E. Sudbay Jr. and his wife Jeannie, Sally Ann Kane and her husband Kevin, and David J. Sudbay and his fiancée Sue Hayden. Don is also survived by his six grandchildren, Caroline Sudbay, Bradlee Sudbay and his wife Megan, Brenden Kane, Andrew Kane, Sara Sudbay, David (DJ) Sudbay and great granddaughter Riley, step-grandchildren Jacqueline Sullivan, Timothy Sullivan and his wife Quinn, and Christine Sullivan, and step-great grandchildren Timothy, Lily and Brendan Sullivan along with many nieces and nephews.
