Wednesday, May 9, 2018.

Met at eleven minutes past eleven o'clock A.M. (Mr. Boncore in the Chair).

The Chair (Mr. Boncore), members, guests and staff then recited the pledge of allegiance to the flag.

The Honorable Nick P. Collins at two minutes past twelve o'clock noon, on Wednesday, May 9, 2018 before His Excellency the Governor, Lieutenant-Governor and Council, did take and subscribe the oath of office as State Senator from the First Suffolk district.
