The President, members, guests and staff then recited the pledge of allegiance to the flag.

There being no objection, the President handed the gavel to Mr. Feeney for the purpose of an introduction. Mr. Feeney then introduced, in the Senate Gallery, the Mansfield High School Quiz Bowl Team. The team was recognized for competing in a round of over 100 schools and had advanced to the round of 16. The Senate applauded their accomplishments and they withdrew from the Chamber. The students were led by teachers and advisors.

There being no objection, the President handed the gavel to Mr. Timilty for the purpose of an introduction. Mr. Timilty then introduced, on the Rostrum, Thomas Rich, Corporate Safety Director at Walsh Brothers. The Greater Boston Chapter of the American Society of Safety Engineers celebrates North American Occupational Safety and Health Week and Occupational Safety and Health Professional Day. The Greater Boston Chapter was being recognized for its efforts to increase awareness of the importance of safe workplaces for all. I'm incredibly proud and humbled to be here with you, serving as a member of the Senate.

As a former member of the House, like some of you, and as the son of a former member, I really enjoyed my time in the House and believe it has prepared me to serve in this august body ably.

I wouldn't be here without the support of many- my family, particularly my wife Olivia who couldn't be here today and our new baby Justine. My parents, siblings, aunts, uncles, cousins, my campaign team, supporters, my staff, past and present and the good people of South Boston, Dorchester, Mattapan and Hyde Park.

I want to recognize and thank my predecessors who came before me-Senator Forry, former Senator Hart and Congressman Lynch for their support and precious stewardship of this office.

Also, I want to recognize some great friends and supporters who have joined us today and without whom I wouldn't be here. There being no objection, at a quarter past twelve o'clock noon, the President declared a recess subject to the call of the Chair; and, at six minutes before two o'clock P.M., the Senate reassembled, the President in the Chair.

At five minutes before two o'clock P.M., Mr. Brady doubted the presence of a quorum. The President, having determined that a quorum was not in attendance, then directed the Sergeant-at-Arms to secure the presence of a quorum.

Mr. Pacheco in the Chair, the Orders of the Day were further considered as follows:

The Senate Bill modernizing the foundation budget for the 21st century (Senate, No. 2325),-- was read a second time.

Foundation budget.

Remarks of Senator Dean A. Tran.

Well, thank you Madam President and thank you for this opportunity to address my esteemed colleagues. I should add you look wonderful today, Madam President. Many of our colleagues do not know that you and I have something in common, that is, by way of the great little town called Clinton. I called it my first real home after emigrating to the United States and it is located in both of our districts. Further, thank you, Madam President, for your professionalism, leadership, and friendship since I've joined the Senate.

Madam President, I would also like to recognize the friendships I have made on both sides of the aisle. My colleagues have been tremendously helpful, yet, I still have not been able to get my hair to be like Senator Rush from Norfolk and Suffolk. I am especially grateful for the mentorship of the Senator from First Essex and Middlesex, Senator Tarr. I aspire to be as funny as he is behind this podium.

Madam President, I would like to tell a story of a little boy who was born in a war-torn, impoverished country, where his father served in the army fighting for freedom while his mother kept him and his siblings safe. When their country fell to communism, his family spent every penny in their possession and struggled to get him and his five siblings onto a wooden boat in search of freedom. That search led them to the town of Clinton and that freedom led to a great education. Through hard work, that little boy became the first Vietnamese-American elected to the Massachusetts State Legislature.

Immigrating to the greatest country in the world at a young age, allowed me to acquire the best education possible. My exceptional public education came from Clinton and Fitchburg. Those experiences gave me the necessary knowledge and tools that paved a path to Brandeis University and a successful private sector career. I have truly lived the American Dream. Now, I'm in a position to ensure that these opportunities are available for generations to come.

Madam President, we must not forget, that a great education in this amazing country is the guiding light to fulfill the American Dream. We, as a body, must acknowledge that a good education from Pre-K through college should be affordable and accessible to everyone. It is our responsibility, in our decision making, that we responsibly fund the education systems under our purview to ensure that they translate to strong outcomes for all of our children. They are our

How important is a good education? It is important enough for me to spend my maiden speech discussing it. The current funding formula under the Chapter 70 foundation budget is archaic, and it is time for our body to institute the necessary changes recommended by the Foundation Budget Review Commission. Our children deserve the best. They are born into a country with endless opportunity and infinite potential, but we need to provide the guiding light to lead them there.

Madam President, I know what it is like to be born in a country where students aren't given the freedom and the right to a good education and I know what it is like to have children in public schools. This is personal.

So today, on behalf of all the educators, parents, and students, I humbly ask my colleagues to join me in thanking the Senator from Second Suffolk, Senator Chang-Diaz for her work and voting in the affirmative to modernize the foundation budget for the 21st century. Thank you, Madam President, and I would like to ask that when the vote is called it be called by a vote of the yeas and nays.

On motion of the Ms. Chang-Díaz, the above communication was ordered printed in the Journal of the Senate.

The President in the Chair prior to the remarks of Mr. Tran, after further remarks, and pending the question on adoption of the amendment previously recommended by the committee on Ways and Means, substituting a new draft with the same title (Senate, No. 2506), and pending the main question on ordering the bill to a third reading, Messrs. Tarr, Ross and Fattman moved that the proposed new draft be amended by inserting after section the following section:-

"SECTION_. Chapter 10 of the General Laws is hereby amended by inserting after section 35DDD the following section:-

Section 35EEE. Learning Innovation for Tomorrow Fund

Section 35EEE. There shall be established and set upon the books of the commonwealth a separate fund to be known as the Learning Innovation for Tomorrow (LIFT) fund, whose purpose shall be to finance the development and implementation of innovation in the public education of students throughout the commonwealth, without regard or preference to any particular geographic location or region of the commonwealth.

Amounts shall be credited to the fund pursuant to clause (i), (ii) and (iii) of this section, provided that the fund may be supplemented through appropriation from the general fund or other available sources including but not limited to any interest earned on monies in the fund; any funds from private sources including, but not limited to, gifts, grants and donations received by the commonwealth that are specifically designated to be credited to the fund, provided further that expenditure from the fund shall be made pursuant to a specific line item created to distribute funding by the Department of elementary, and secondary education.

Funds may be expended from the fund for the following purposes:

(1) To fund the recommendations of the Foundation Budget review commission as established under section 4 of chapter 70 in accordance with the implementation schedule established under section 1 of this act

In promulgating regulations to administer the fund, the department shall establish and monitor measurable benchmarks for progress and accomplishment, and shall report annually to the clerks of the house and senate, the house and senate committees on ways and means, the joint committee on education, and the secretary of education not later than December 31 of each year on the impacts of

fund spending.";

By inserting after section the following section:-

"SECTION_.(i). Section 64 of chapter 23k of the general laws as appearing in the 2014 official edition is hereby amended by striking out from line 6-12 the following:- 'provided, however that 35 per cent of the funds received shall be appropriated for the purposes of higher education to supplement, not offset, any reduction in the general appropriation act from the previous fiscal year; and provided further, that any expenditures from the fund for K-12 education shall be used to supplement, and not offset, any reduction in line item 7061-0008 of the general appropriation act from the previous fiscal year's general appropriation act' and inserting in place thereof the following:- 'provided, however, that 40 per cent of the funds received shall be appropriated for the purposes of higher education and provided further, that 60 per cent of the funds received shall be appropriated to the learning education for tomorrow fund as establish under this act'.

- (ii). Section 10 of chapter 152 of the acts of 1997 are hereby amended by inserting in at the end of sub clause (iii) in clause (C) the following:- (iv) Not less than twenty million plus fifty per cent of surplus over required debt service to the learning education for tomorrow fund as establish under this act.
- (iii). Notwithstanding any general or special law to the contrary, prior to transferring the consolidated net surplus in the budgetary funds to the Commonwealth Stabilization Fund under section 5C of chapter 29 of the General Laws, the comptroller shall dispose of the consolidated net surplus in the budgetary funds as follows: (1) transfer 1/3 of the surplus, not to exceed \$10,000,000, to the Massachusetts Community Preservation Trust Fund established in section 9 of chapter 44B of the General Laws; (ii) transfer 1/3 of the surplus, not to exceed \$10,000,000, to the Massachusetts Life Sciences Investment Fund established in section 6 of the chapter 23I of the General Laws; and (iii) transfer 1/3 of the surplus, not to exceed \$10,000,000 to the learning innovation for tomorrow fund established under this act."; and

By inserting after section ___, the following section:-

"SECTION . Chapter 195 of the acts of 2014 are hereby repealed."

After remarks, the amendment was rejected.

Messrs. Tarr and Ross moved that the proposed new draft be amended by inserting after section 1 the following section:-

"SECTION 1A. Chapter 70 of the General Laws, as appearing in the 2016 Official Edition, is hereby amended by striking section 4 and inserting in place thereof the following section:-

Section 4. There shall be a foundation budget review commission to review, every 5 years, the way foundation budgets are calculated and to make recommendations for potential changes in those calculations, as the commission deems appropriate. In conducting the review, the commission shall seek to determine the educational programs and services that are necessary to achieve the commonwealth's educational goals and to prepare students to achieve passing scores on the Massachusetts Comprehensive Assessment System examination or any successor assessment as determined by the board. The review shall include, but not be limited to, the components of the foundation budget established under section 3 and subsequent changes made to the foundation budget by law. In addition, the commission shall seek to determine and recommend measures to promote the adoption of ways in which resources can be most effectively utilized and consider various models of efficient and effective resource allocation. In carrying out the review, the commissioner of elementary and secondary education

shall provide to the commission any data or information that the commissioner considers relevant to the commission's charge.

The commission shall include: the house and senate chairs of the joint committee on education, who shall serve as co-chairs; the secretary of education; the commissioner of elementary and secondary education; the commissioner of early education and care; the speaker of the house of representatives or a designee; the president of the senate or a designee; the minority leader of the house of representatives or a designee; the minority leader of the senate or a designee; the governor or a designee; the chair of the house committee on ways and means or a designee; the chair of the senate committee on ways and means or a designee; and 1 member to be appointed by each of the following organizations: the Massachusetts Municipal Association, Inc.; the Massachusetts Business Alliance for Education, Inc.; the Massachusetts Association of School Committees, Inc.; the Massachusetts Association of School Superintendents, Inc.; the Massachusetts Teachers Association: the American Federation of Teachers Massachusetts: the Massachusetts Association of Vocational Administrators, Inc.; the Massachusetts Association of Regional Schools, Inc.; and the Massachusetts Association of School Business Officials. Members shall not receive compensation for their services but may receive reimbursement for the reasonable expenses incurred in carrying out their responsibilities as members of the commission. The commissioner of elementary and secondary education shall furnish reasonable staff and other support for the work of the commission. Prior to issuing its recommendations, the commission shall conduct not less than 4 public hearings across regions of the commonwealth.

It shall not constitute a violation of chapter 268A for a state employee or a person employed by a school district to serve on the commission or to participate in commission deliberations that may have a financial impact on the district employing that person, the commonwealth, or the rate at which that person may be compensated; provided, however, that the commission may establish procedures to ensure that such a person shall not participate in commission deliberations that may directly affect the school districts employing such a person or that may directly affect the rate at which such a person is compensated."; and by inserting after section 2 the following section:-

SECTION 3. Section 1A shall take effect upon the adoption of the joint resolution affirming that the recommendations of the commission have been fulfilled, as provided in subsection (b) of section 5B½ of chapter 29 of the General Laws."

Adjourn In Memory of Representative Chris Walsh

The Senator from Middlesex and Norfolk, Ms. Spilka, moved that when the Senate adjourns today, it adjourn in memory of Representative Chris Walsh of Framingham.

On May 2, 2018, Chris Walsh died peacefully after a long battle with cancer. He was dearly loved by his wife, Cindy, his two children, and his colleagues, friends and community. During his battle with his illness, he always remained positive and maintained an unrelenting commitment to his constituents. He will be remembered for, among other things, his wit, intellect and perseverance.

Chris worked his way through college at the Rhode Island School of Design, and had a long, successful career as an architect and designer. Walsh's enthusiasm for his community inspired his political pursuits. Walsh was elected to Town Meeting in 1992, then served as a Framingham Public Library trustee and member of the board of Amazing Things Arts Center. In 2012, he was elected to the Massachusetts House of Representatives, where he continued to serve until his passing. Hard work, passion, and a unique perspective characterized his life's work. Chris dedicated his life to proudly serving his community of Framingham.

Chris was a thoughtful, funny and generous man who left a lasting impression on everyone he met. His kindness and friendly smile will be sorely missed by his family, friends and colleagues.
