*Adjourn In Memory of Robert Hayden*

Mr. O'Connor in the Chair, Senators O'Connor, L'Italien, Rush, Forry and Boncore moved that when the Senate adjourns today, it adjourn in memory of Robert Hayden.

Robert Hayden, a Hingham resident who dedicated his life to public safety and played a significant role in making Massachusetts a safer place to live, passed away on February 25th at the age of 74 after a courageous battle with cancer. He served the people of the Commonwealth for almost five decades working for three different cities. What Robert was able to achieve from within the police force is remarkable. He forged an illustrious career and legacy that will be highly regarded by Massachusetts police for years to come.

His communities call him a "legendary cop". This colloquial title comes as no surprise. Officer Hayden quickly ascended the ranks, beginning his career in the Boston Police Department as a patrolman in 1966. Following in the footsteps of his father, he became a detective, and eventually rose to become the deputy superintendent of the Boston Police Department. He proved his strength and

tenacity to such an extent that in 1994, he was transferred to become the Lawrence Chief of Police. In his three years serving the people of Lawrence, he transformed the department. By the time he left, the number of arrests was up 700% from where it was when he first began.

He was then asked to lead the Brockton Police Department in 2014. Officer Hayden, at the age of 72 and battling prostate cancer, went back into the force and began working in his third department. In recounting his steps throughout his career, it is truly amazing to see how he could go from city to city, leaving each one a safer and more secure place, as if he knew some secret formula to eradicate criminal activity.

Officer Hayden is not only known for his profound experience and expertise in public safety. Many might know him more for his extraordinary caliber as a human being. He was a 4-time marathon runner and long distance biker. He took his bicycling hobby to new levels, traveling from Boston to Montreal and across the entirety of Ireland. In 2001, he was recognized for his athleticism and appeared on the reality TV series “Lost” in Bolivia. Over the years, he suffered numerous serious injuries that had him in the hospital for months. At 72, I think many of us would have thrown in the towel. But not Officer Hayden. After breaking his nose from a fall during a run down a mountain, his coworkers found him on the job two days later, still bruised and bandaged, without a care for himself, only with the ability to put the wellbeing of others before him every single time. This is one of many events that stand as a testament to Officer Hayden’s grit, his toughness, and his spirit.

He was truly ‘a cop’s cop’. Even as his career led him to grander titles he never lost sight of the importance of everyday interactions with his fellow officers and the public that he served. We in this chamber, and every other public servant in Massachusetts, could learn great things from the trials that Officer Hayden has endured.

Officer Hayden is survived by his four children, nine grandchildren, his sister, and many nieces, nephews, and friends.
