Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Gloria Phillips, an employee of the Department of Industrial Accidents (see House, No. 4336, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Boncore) and sent to the House for enactment.

A lifelong resident of Salem, Edith worked at the family owned North Street Arena which stood where the current North Street overpass is today. Edith attended Salem High School, Class of 1943. As a young lady, Edith worked at General Electric and also for a time as a telephone operator at New England Telephone.
