*Engrossed Bill Returned by Governor with Recommendation of Amendment.*

The engrossed Bill to promote and enhance civic engagement (see Senate, No. 2631) (which on Wednesday, July 25, 2018, had been laid before the Governor for his approbation), was returned to the Senate Clerk by the Governor on Friday, August 3, 2018, at a quarter past three o’clock P.M., with a message recommending an amendment.

At the request of the Chair (Mr. Brownsberger), the members, guests and staff stood in a moment of silence and reflection to the memory of Senator and Rear Admiral John Francis Aylmer.

*Adjourn In Memory of Former Senator John Francis Aylmer.*

The Senator from the Cape and Islands, Mr. Cyr, moved that when the Senate adjourns today, it do so in memory of John "Jack" Aylmer of Centerville.

Mr. Aylmer lived a long and memorable life, serving his country in the United States Navy and as the Senator for Barnstable, Dukes, Nantucket, and Plymouth counties for six consecutive terms from 1971 - 1982.

Mr. Aylmer was a Cape local to his core. Born and raised on the Cape, he endlessly contributed to his community through hard work and tireless service. After graduating from Barnstable High School, Jack pursued a Bachelor of Science degree from Massachusetts Maritime Academy, an education that was entirely self-funded through his work operating a tugboat for the New England Dock & Dredge Company. After he graduated, he began his Navy service and spent two years aboard the USS Mattabasset in the Mediterranean during the United States' intervention in Lebanon. He received an honorable discharge from the Navy and continued his maritime career as a Merchant Marine Officer and then Commander in the United States Navy Reserve for 23 years until his retirement. Jack split his time between his career on the water and his career as a public servant. He took his first step toward a political career in 1966 when he ran and was elected to the Town of Barnstable's Board of Selectmen. At the same time, he was receiving his Master's Degree in Education from Bridgewater State University. In 1970, he ran for his first term as a member of the Massachusetts State Senate representing thirty-six towns in Plymouth County, Cape Cod, and the Islands. During his six-term tenure in office, he made legislative contributions that have shaped Cape Cod to this day. He authored and supported numerous bills that led to the preservation and establishment of the Cape's most famous historic sites and shorelines. Senator Aylmer was appointed Assistant Senate Minority Leader and served on the Senate Ways and Means Committee while in office. In 1981, his alma mater, the Massachusetts Maritime Academy, appointed him to the prestigious position of President of the college and Rear Admiral, U.S. Maritime Service. Admiral Aylmer led Massachusetts Maritime Academy for ten years. Mr. Aylmer managed to juggle military service, community service, and a

political career all while maintaining involvement in his favorite pastime, the long-time tradition of baseball on the Cape. He played for the Barnstable Barons in 1952 and eventually helped found two Cape Cod Baseball League teams later in his life, in Hyannis and Bourne. He earned a spot in the Cape Cod Baseball League Hall of Fame in 2012. He is survived by his beloved wife Anne, his three sons, John Jr., Peter, Patrick, and his seven grandchildren. Senator Aylmer serves as an example for us all, to work passionately and tirelessly for our country and communities, and to create lasting positive change for generations to come. We mourn our former colleague and may he rest in peace.
