Thursday, August 9, 2018.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Jodi Cipriano, an employee of the Department of Developmental Services (see House, 4554), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Ms. Friedman) and sent to the House for enactment.

A Bill relative to the assessment of betterments for improvements to private ways in the town of Sandwich (House, No. 3711, amended,-- on petition) [Local approval received],-- was read.

A Bill authorizing the town of Montague to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises (House, No. 4462, amended,-- on House, No. 4340) [Local approval received on House, No. 4340],-- was read.

In addition to his wife, those left to cherish his memory are his children, Ashley McHarrie and her husband, John, of Salem; Scot and Michael Tracht, both of Brockton; and his treasured granddaughters, Maggie and Chloe McHarrie. He also leaves his brother Leon Tracht and his wife Arlene of Tarpon Springs, Florida, as well as many close friends and extended family.
