Monday, August 13, 2018.

Met at two minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

*Adjournment in Memory of Benjamin Cheney Moore.*

The Senator from Cape and Islands, Mr. Cyr moved that when the Senate adjourns today, it do so in memory of Benjamin Cheney Moore of West Tisbury.

Benjamin Cheney Moore’s battle with Alzheimer’s and Parkinson’s disease ended on May 10, 2018. Mr. Moore was 82. Born in Hartford, Connecticut to a family with a long lineal connection to the Vineyard, Mr. Moore grew up to continue his family’s tradition of contributing to the evolution of their beloved island. He received an elite education from the Yale School of Architecture before moving to

Boston to continue his career as an architect. Compelled to “give the Vineyard a try,” Mr. Moore moved with his wife Paddy to a farmhouse in 1975. Thus began Mr. Moore’s long and fruitful career as an essential member of the island community. Not only did he continue to design homes for private residents, but he also used his talent to restore and improve numerous island establishments with thoughtful design and environmental consciousness in mind. He was also a devoted public servant. Mr. Moore served for 10 years as the West Tisbury representative to the Martha’s Vineyard Commission, a position that he carried with calmness and ease, even during tumultuous periods in the Vineyard’s history. He served for 20 years as a member of the West Tisbury Historic District Commission and co-founded the Vineyard Habitat for Humanity. Over the course of his life, Mr. Moore did not cease to contribute to his home on the island and is remembered by the community for his modesty, his strong moral compass, and his acute sense of honesty.

He is survived by his wife Paddy, his sons Max, Andrew, Hubbard, Patrick, Gus, and Jason, his siblings Martha and Alexander, and his many beloved grandchildren, nieces, and nephews. May he rest in peace, having left his legacy on Martha’s Vineyard through his work as an architect, a public servant and community leader, a father, a husband, and friend to many.

Accordingly, as a mark of respect to the memory of Benjamin Cheney Moore, at nineteen minutes past eleven o’clock A.M., on motion of Mr. deMacedo, the Senate adjourned to meet again on Thursday next at eleven o’clock A.M.
