Mr. O'Connor in the Chair, on August 10, 2018, Walter A. McKinnon of Bridgewater passed away with his loving family by his side at the age of 94.

Walter was born and raised in Quincy, and after high school, he enlisted in the United States Army and served from 1943-1946 in the 75th Infantry in Germany, where his division engaged in defensive combat. He was awarded the Bronze Star during his service for bravery and acts of merit. When Walter returned, he married his wife, Dorothy, and they settled in Weymouth to start their family.

During this time, Walter attended Northeastern University, where he received a Bachelor's Degree in Engineering. He went on to own and operate Walter A. McKinnon Associates, a Weymouth-based engineering firm, for over 25 years.

Walter was known throughout the South Shore community for his engagement in the Weymouth Rotary Club and the Hatherly Country Club in Scituate, where he loved to play golf.

Walter was predeceased by his beloved wife of 66 years, Dorothy (Faunce) McKinnon and his son Richard McKinnon. He is the loving father of Wally McKinnon and his late wife Elaine of Braintree, Leslie Lydon and her late husband William of Bridgewater, Nancy McKinnon and her partner Rebecca Robinson of Stetson, Maine, and his daughter-in-law Barbara McKinnon of Whitman. He is the cherished grandfather to Cheryl and Jeffrey Larson, Karen and Laura McKinnon and great-grandfather to Will and Ava Larson.
