Thursday, September 20, 2018.

Met at six minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

The House Bill authorizing the city of Beverly to employ Paul Cotter as Fire Chief beyond the statutory requirement age (House, No. 4488),-- was read a third time.

Pending the question on passing the bill to be engrossed, Ms. Lovely presented an amendment in section 1, by inserting after the word "until", in line 3, the first time it appears, the following words:- "he reaches 70 years of age, until".

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment.
