Thursday, October 18, 2018.

Met at thirteen minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

PAPERS FROM THE HOUSE.

A joint petition (accompanied by bill, House, No. 4931) of Sean Garballey and Cindy F. Friedman (by vote of the town) relative to the town manager of the town of Arlington,-- was referred, in concurrence, to the committee on Municipalities and Regional Government.

A Bill designating a certain Exit on State Route 18 the Giammalvo Family Memorial Exit (House, No. 4912,-- on petition),-- was read and, under Senate Rule 26, referred to the committee on Rules.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Richard G. Perry, an employee of the Department of Conservation and Recreation (see Senate, No. 2661), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President (Mr. Boncore) and sent to the

House for enactment.

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The House Bill exempting the position of part-time police officer in the police department in the town of Athol from the civil service law (House, No. 4146) (its title having been changed by the committee on Bills in the Third Reading),-- **was read a third time and passed to be engrossed, in concurrence.**

The House Bill relative to the disability retirement of public safety personnel in the city of Quincy (House, No. 4719),-- **was read a third time and passed to be engrossed, in concurrence.**

PAPER FROM THE HOUSE

Engrossed Bill Returned with Recommendation of Amendment.

A message from His Excellency the Governor, returning with recommendation of amendment the engrossed Bill supporting the Mohawk Trail Woodland Partnership (see House, No. 4880) [being the text contained in Section 90 of the engrossed bill House, No. 4835] [for message, see House, No. Attachment B of House, No. 4884],— came from the House with endorsement that the House adopted the amendment recommended by the Governor (as approved by committee on Bills in the Third Reading), as follows:

Mohawk Trail Woodland Partnership.

By striking out all after the enacting clause and inserting in place thereof the following text:-

“To capitalize the Mohawk Trail Woodland Partnership Fund established in section 89 of chapter 209 of the acts of 2018 and support the goals of the Mohawk Trail Woodland Partnership, the partnership may receive funds from general appropriations, capital expenditure authorizations, grants or a combination thereof; provided, however, that upon any money from any source being credited to the fund, the meetings of the partnership board and its executive committee shall be subject to sections 18 to 25, inclusive, of chapter 30A of the General Laws and all officers, directors, and agents of the partnership, including all officers, directors and employees of any administrative agent or fund manager designated by the partnership under paragraph (6) of subsection (e) of section 91 of chapter 209 of the

acts of 2018, shall, in connection with their service for the partnership: (i) comply with all applicable state finance laws; (ii) be considered officers or employees of an agency, commission or authority of the commonwealth for the purposes of clause Twenty-sixth of section 7 of chapter 4 of the General Laws; and (iii) be considered special state employees for purposes the of chapter 268A of the General Laws.”.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was before the Senate subject to amendment and re-enactment.

The rules were suspended, on motion of Mr. Rodrigues, and the Governor’s amendment was considered forthwith.

On motion of Mr. Tarr, the Governor’s amendment was adopted, in concurrence (as corrected BTR).

Sent to the House for re-enactment.

Reports of Committees.

By Ms. Lovely, for the committee on Ways and Means, that the Senate Bill establishing a sick leave bank for Laurie Wendover, an employee of the Department of Correction (Senate, No. 2083),-- ought to pass, with an amendment striking out the third sentence.

There being no objection, the rules were suspended, on motion of Mr. Rodrigues, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means.

The bill (Senate, No. 2083, amended) was then ordered to a third reading, read a third time and passed to be engrossed.

By Ms. Lovely, for the committee on Ways and Means, that the House Bill relative to the financial condition of the city of Methuen (House, No. 4905, changed and amended),-- ought to pass.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: “An Act providing for the financial stability of the city of Methuen”.
