Met at ten minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The Senate Bill amending the charter of the city of Somerville (Senate, No. 2664),-- was read a second time.

The amendment was adopted.

The bill (Senate, No. 2676) was then ordered to a third reading, read a third time and passed to be engrossed.

Sent to the House for concurrence.

The House Bill authorizing the city of Chicopee to establish a water and sewer department (House, No. 4914),-- **was read a third time and passed to be engrossed, in concurrence.**
