*Adjourn In Memory of Lillian C. Samoluk*

The Senator from Cape and Islands, Mr. Cyr, moved that when the Senate adjourns today, it adjourn in memory of Lillian C. Samoluk of South Dennis.

Lillian passed away peacefully at the Liberty Commons Nursing Home in North Chatham on Tuesday, January 17, 2017. She was a devoted wife, mother, grandmother, great grandmother, and a friend to all with whom she came into contact during her long and loving life. Family always came first for Lillian and many learned from the example that she set.

Born in Boston, Mrs. Samoluk was later a resident of Framingham for 43 years, prior to moving to South Dennis with her husband, Walter, in 2005. Lillian and Walter were married for 59 loving years. Prior to his death in 2008, Mr. Samoluk characterized his wife as "the most wonderful woman in the world." together, they achieved the "American dream" with a loving family of six children, a warm home, and a successful small business, built from scratch.

Mrs. Samoluk was a proud graduate of Roslindale High School in Boston. She later attended secretarial school before working for John Hancock Mutual Life Insurance Company from 1942 to 1949, where she met her future husband, Walter. Lillian was the moral compass and backbone of her family. She was a devout Catholic and a woman of deep faith, who for most of her life said the rosary every night.

Mrs. Samoluk is survived by five of her six children; Carol Dennington and her husband Roy, of Clinton; Walter and his wife, Shelley, of South Dennis; George and his wife, Patricia, of Sandwich; Thomas and his wife, Carrie of Andover; and Robert of South Dennis and Boston. She is also survived by her niece, Sonia Shea of Waltham; 11 grandchildren; and 10 great grandchildren. Lillian is predeceased by her husband, Walter and her daughter, Patricia, who was married to Paul Rene.
