Wednesday, March 22, 2017.

Met at eight minutes past one o'clock P.M. (Ms. Chandler in the Chair).

Distinguished Guest.

There being no objection, the President handed the gavel to Mr. Eldridge for the purpose of an introduction. Mr. Eldridge then introduced, in the rear of the Chamber, his office aide Melissa Reilly. Melissa was recognized for winning the gold medal in downhill skiing and the silver medal in slalom at the Massachusetts Special Olympics Winter Games held at Wachusett Mountain. She was also recognized for being a part of the MDSC's Self Advocate Advisory Council and "Your Next Star" campaign, aimed at raising awareness about the power of people with down syndrome in the workplace. As a self-advocate, she speaks to many groups, schools and other organizations about her life with Down Syndrome and about the Special Olympics. The Senate applauded her accomplishments, she approached the Rostrum for congratulations and she withdrew from the Chamber.

A Bill making appropriations for the fiscal year 2017 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 3448, amended,-- on House, No. 72),- was read.

There being no objection, the rules were suspended, on motion of Ms. Spilka, and the bill was read a second time, ordered to a third reading and read a third time.

After remarks, the question on passing the bill to be engrossed was determined by a standing vote, on motion of Mr. Tarr, and it was passed to be engrossed, in concurrence, by a vote of 22 to 0, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act making appropriations for fiscal year 2017 to provide for supplementing certain existing appropriations and for certain other activities and projects".

Emergency Preamble Adopted; Engrossed Bill Enacted.

Mr. Walter F. Timilty in the Chair, an engrossed Bill making appropriations for fiscal year 2017 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 3448, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 5 to 0.

The bill was signed by the Acting President (Mr. Walter Timilty) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair) and sent to the House for enactment.

Subsequently, the bill, which originated in the House, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Mr. Walter Timilty).
