*Ordered*, that there shall be a special committee on the part of the Senate on cyber security readiness. The committee shall consist of 5 members of the Senate, 4 of whom shall be appointed by the President of the Senate and 1 of whom shall be appointed by the Minority Leader of the Senate. The committee shall review and make recommendations for the state to improve its cyber security readiness, enhance technological responses to homeland security and public safety threats, and further protect financial, medical and other sensitive information. The committee shall file its report, with any recommendations for legislation, with the clerk of the senate by March 30, 2018 (Senate, No. 2060).

*Remarks of Senator Michael O. Moore.*

As we continue to evaluate and establish our priorities for public safety and security in the Commonwealth, there must be an increasing emphasis on issues of cyber security.

Remarks of Senator  
Michael O. Moore.

To that end, this Special Committee will focus on identifying the needs of our public safety officials in the cyber realm, and providing them with the tools necessary to protect Massachusetts residents.

From bank accounts to medical records, energy systems and law enforcement information, sensitive material is increasingly being stored online. With that has come the advent of cyber criminals who have the ability to inflict tremendous damage from anywhere in the world.

These attacks can result in serious human and economic costs, and how we prepare to meet these threats will ultimately determine the degree of harm. The potential for serious threats necessitates a thorough review of our existing cyber security defenses.

While there will be improvements to make within our own borders, the Committee will also need to consider the way we interact with the federal homeland security apparatus.

Officials from the Department of Public Safety, and other institutions like the Commonwealth Fusion Center have already begun to confront these issues, and the committee will aim to supplement these efforts.

I am hopeful that by engaging with strategic partners and evaluating the strength of our operations, we can better protect the people of Massachusetts from these threats.

Our expanding reliance on technology will require us to constantly evaluate and invest in the protection of state networks, and the establishment of strong cyber security policies.

I'd like to thank the Senate President for his commitment to this vital issue, and I look forward to working with all of you to make this a success.

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it adjourn in memory of Christine Tarr of Gloucester.

Christine Tarr of Gloucester passed away on January 21, 2017 at the age of 95. Born November 29, 1921 to Constantine and Jennie Taliadoros, Christine was a joyous presence among her six brothers and sisters.

Growing up on the family farm, Christine developed a love for animals that became an integral part of her life. The Gloucester community could always count on Christine's caring heart whenever an animal needed a new home; she never turned away an animal that needed sheltering resulting in a farm filled with cats, goats, horses, and miniature ponies. Despite tending to the farm most days, Christine found time to establish her own professional career, working for more than 15 years at the pelage's glue factory in Gloucester and at Jordan Marsh in Peabody where she loved interacting with customers.

In 1950, Christine married Edward "Murph" Tarr with whom she had three sons: Brian, Brent, and Bruce. Their family settled on the farm where Christine had grown up and she took every opportunity to impart upon her sons all that the farm had taught her over the years. She instilled in each of her children a strong spirit, a



caring nature, and a sense of duty to their community. Each son found a different way to echo these fundamental principles in their everyday lives. All would agree that they are a testament to Christine's incredible legacy.

Christine was always full of adventure which she loved to share with her granddaughters, Elizabeth and Emily. She loved to take them to performances at the north shore music theater and cherished long summer days spent swimming with them at the family pool. As her granddaughters grew up, she shared her love of the farm and it is no surprise that both Elizabeth and Emily are steadfast animal lovers. Christine also had a passion for gardening and knitting, hobbies she shared with her family. She loved knitting her sons and granddaughters sweaters to keep them warm throughout the winter and she often spent mild spring days in her garden with her sister-in-law, Dorothy.

Christine was never just one thing in her life. She was a mother, a grandmother, and a friend. She was a gardener, a knitter, and a swimmer. She lived her life to the fullest in every possible way and she is remembered as a strong, hardworking role model by her family and friends. Christine is survived by her sons, Brian and Bruce of Gloucester; Brent and wife, Cathy of Gloucester; granddaughter, Emily and partner, James of Gloucester; granddaughter Elizabeth Lung and her husband, Michael of Millstone, New Jersey; her brother Anthony Taliadoros and wife Arlene of Essex; and her sister-in-law, Dorothy Taliadoros of Gloucester.
