*Adjourn In Memory of Dr. Judy Bradford.*

The Senator from Essex and Middlesex, Ms. L'Italien, moved that when the Senate adjourns today it do so in memory of Dr. Judy Bradford.

Judy Bradford, PhD, was Co-Chair of the Fenway Institute at Fenway Health from its founding in 2001. The Fenway Institute is a world-renowned center for research, education and training, and policy development focused on LGBT health and HIV prevention and care.

Dr. Bradford was a leading HIV researcher in the early days of the epidemic, a lesbian health researcher, and then an LGBT health researcher.

Dr. Bradford played a key role in building a framework for LGBT-focused research and teaching. She was the first research scientist to head a National Institute of Health (NIH) funded population studies center focused on sexual and gender minority health, and the first to receive NIH funding to support a summer institute to train the next generation of LGBT health researchers.

Dr. Bradford was a key influencer of NIH policy as a member of the Council of the National Institute of Minority Health and Health Disparities (NIMHD).

Dr. Bradford served on the first Institute of Medicine (IOM) panel focused on lesbian health in the late 1990s, and then was key in the IOM's 2011 landmark report on sexual and gender minority health disparities. She was a passionate believer in improving the health of our community by performing sound research and by teaching others how to do this research.

Dr. Bradford was also a leading demographer who helped document the existence of gay, lesbian and bisexual people and same-sex couples across the US by analyzing the 1990 and 2000 Census data on same-sex couple households.

Dr. Bradford lost a heroic, several year battle with cancer in February 2017. Despite her health condition, during the last years of her life Dr. Bradford led a groundbreaking NIMHD-funded research project on health disparities affecting LGBTQ youth of color in Greater Boston. She launched a bisexual health research project with leading researchers from across the U.S., and participated in White House meetings on bisexuality.

Dr. Bradford was a leading research on older LGBT people. She conducted groundbreaking research on LGBT elders in Massachusetts through the Massachusetts LGBT Aging Needs Assessment in 2009, and helped launch the first-in-the-nation statewide Special Legislative Commission on LGBT Aging in 2014.

Dr. Bradford played a key role in promoting the addition of sexual orientation and gender identity questions to health and demographic surveys, and in developing standards for measuring sexual orientation and gender identity in health care and other clinical settings.

As a result of Dr. Bradford's visionary research, education, and advocacy with government officials, we know more about LGBT health and demography, and about how to prevent HIV infection and keep people living with HIV healthy. The General Court of Massachusetts acknowledges her significant contributions to the LGBT community in the Commonwealth of Massachusetts and across the nation and world.
