Adjourn In Memory of Mary Singleton

The Senator from Cape and Islands, Mr. Cyr, moved that when the Senate adjourns today, it adjourn in memory of Mary Singleton of West Yarmouth.

Mary passed away at the Mary McCarthy House in Sandwich surrounded by her family on May 1, 2017.

Mary was a loyal employee of the town of Yarmouth for 40 years, 33 of which were spent proudly serving as the secretary at the Yarmouth Fire Department. Being a part of the fire department was a huge part of Mary's life. She took care of YFD. and they took care of her. She became an honorary member of Local 2122 as well as an honorary member of the International Association of Fire Fighters on December 5, 1998. Upon her retirement in 2009, she had served under six fire chiefs and was known for caring as much for the fire fighters and their families as she did her own family. She always had kind words (and some candy) for all who visited her at the station, and was particularly proud that some of the young children of "her men" would grow up to be fire fighters at the station while she was there as well.

She is survived by her two daughters, Nancy Harris of Rock Hill, South Carolina and Ellen Clarke of Brewster, and her four grandchildren, Erica, Heather, Benjamin and Nicholas. Mary is also survived by her three great-grandchildren whom she adored: Emily, Matthew and Abigail. As the matriarch of the family, she had made it her goal to see all of her family together once a year for a family vacation, a tradition that has held for several years. She was predeceased by her husband David, her son Paul, her sister Catherine and her parents.
