Adjourn In Memory of Dr. Irvin L. Kanin

The Senator from Middlesex and Norfolk, Ms. Creem, moved that when the Senate adjourns today, it adjourn in memory of Dr. Irvin L. Kanin.

Newton resident Dr. Irving L. Kanin died on June 21, 2017.

Born in New York in 1921, Dr. Kanin graduated from St. John's University and from Middlesex Veterinary School in 1944.

Dr. Kanin practiced veterinary medicine in Virginia and Maryland, where he treated lions, tigers, and giraffes, among other animals at Largo Wildlife Preserve. Returning to Massachusetts, he was a veterinarian in both Hingham and Needham.

In 1952, Dr. Kanin in collaboration with his beloved wife Doris founded Lynwood Laboratories, at which he remained President up until his death. They invented and developed more than 30 products, including spray-n-starch, which was the first aerosol product of its kind in the United States.

Having strongly protested the war in Vietnam, he was a lifelong activist for civil rights and economic and social justice. Dr. Kanin was tirelessly committed to advocating for a more peaceful world.

Dr. Irving L. Kanin was extremely devoted to his late wife, Doris for 71 years. He will be deeply missed by his children, Dennis, Erik and Lisa, their spouses, his grandchildren, and the Newton community.

Accordingly, as a mark of respect to the memory of Dr. Irvin L. Kanin, at eight minutes before twelve o'clock noon, on motion of Mr. Ross, the Senate
