Met at three minutes past eleven o'clock A.M. (Ms. Chandler in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Chandler), members, guests and staff then recited the pledge of allegiance to the flag.

Adjourn In Memory of Collin R. Ingraham

The Senator from Hampden and Hampshire, Mr. Humason, moved that when the Senate adjourns today it do so in memory of Collin R. Ingraham of Westfield.

On May 16, 2017, Collin passed away at his home in Westfield, surrounded by his loving family, at the age of 73.

Born on March 30, 1944 in Manchester, Connecticut, Collin was raised in Westfield, Massachusetts. He graduated from Westfield High School in 1961, and immediately joined the United States Navy.

Collin attained the rank of Senior Chief Petty Officer in the Navy, and his adventures at sea led to countless stories that Collin would share with friends and families.

He married Gretchen (Holzapfel) Ingraham, the smart girl from his high school German class, and loved her intensely for his whole life.

In 1980, he reluctantly retired from the Navy for his second life as a gentleman farmer, maintenance supervisor at Northeast Utilities, husband, father and world traveler. He excelled in each of these roles.

Collin is survived by his wife of 52 years, Gretchen, his sons and their spouses, Michael and Cara Ingraham of Southampton, and Collin Ingraham and Todd Franson of Adelphi, Maryland, his beloved grand-daughters, Allison and Emily Ingraham and Amanda Ferrara, and his sisters Susan Gallo and Janet Heirholzer of New Port Ritchie, Florida. His brother Jeffrey Ingraham predeceased him. Also left are a legion of those family, friends, and shipmates he touched, taught, inspired and entertained. He will not be forgotten.
